This policy was originally numbered as 7-108 from its adoption in 1988 until 6/12/1992 when it was renumbered as 7-112. On 1/15/1999, it was renumbered as 7-104. It became 7-106 on 6/16/2005.

Policy 7-106, Annual Capital Improvement Plans

7-106 has been the number assigned to multiple policies since the Policy Manual was adopted in 1983. It was originally assigned to the Execution of Construction Contracts policy. Article A of Chapter VII was revised in January 1988 and 7-106 was assigned to the Project Closeout Phase policy. In June 1992, Chapter VII was revised again and 7-106 was assigned to the Construction Phase policy. Upon another revision in January 1999, 7-106 became the Project Initiation Phase policy. Chapter VII was again revised in September 2001 and 7-106 was assigned to the Overview of the Capital Development Process and Phases policy. The number was then used for Annual Capital Improvement Plans from June 2005 until its repeal in June 2022.
