Prohibition on Support for Domestic and Foreign Terrorist Organizations by Student Groups and Organizations

Revision Dates

6/12/2025, 9/27/2024 (adopted)

- A. Federal and State Law, Board Policy 1-119, and applicable state and federal guidance require that all students, including, but not limited to, students who are, or who are perceived to be Jewish, Israeli, Muslim, Arab, or Palestinian, be provided a school environment free from discrimination and harassment based on membership in a protected class.
- B. Board Policy also prohibits:
 - 1. Intentionally or recklessly causing physical harm to any member of the university community;
 - 2. Intentionally or recklessly causing reasonable apprehension of such harm;
 - 3. Engaging in conduct or communications that a reasonable person would interpret as a serious expression of intent to harm; and
 - 4. Engaging in conduct that violates federal, state, or local criminal laws or ordinances.
- C. Consistent with the foregoing, no student group or organization may do the following:
 - 1. Knowingly provide material support or resources to a designated domestic terrorist organization as referenced in 18 U.S.C. 2331(5) or a foreign terrorist organization as defined in 18 U.S. Code § 2339B, including, but not limited to, a designated foreign terrorist organization that calls for the genocide of a group of people, including but not limited to people who are, or who are perceived to be Jewish, Israeli, Muslim, Arab, or Palestinian.
 - 2. Call for violence and/or genocide against any individual or group in violation of federal and state law.
 - 3. Engage in or promote in person or in any other medium, including but not limited to social media, threats of genocide or harm in violation of state or federal law against any member of the university community, including but not limited to people who are, or who are perceived to be Jewish, Israeli, Muslim, Arab, or Palestinian.

- 4. Engage in other conduct in violation of Board Policy 1-119 and/or federal and state law, that interferes with maintaining a school environment free from discrimination.
- D. Student groups and/or organizations who violate this policy and/or 5-305 may face sanctions that include revocation of the use of university facilities for a definite period of time or revocation or denial of recognition or registration, as well as other appropriate sanctions, permitted under the Code of Conduct.
- Ε. As required by Board Policy 1-124, this policy does not prohibit any expressive activity that is protected by the First Amendment to the U.S. Constitution or Arizona Law.
