Rights of Crime Victims in Alaska:

Under Article 1, Section 24 of the Alaska Constitution:

Crime victims, as defined by law, shall have the following rights as provided by law; the right to be reasonably protected from the accused through the imposition of appropriate bail or conditions of release by the court; the right to confer with the prosecution; the right to be treated with dignity, respect, and fairness during all phases of the criminal and juvenile justice process; the right to timely disposition of the case following the arrest of the accused; the right to obtain information about and be allowed to be present at all criminal or juvenile proceedings where the accused has the right to be present: the right to be allowed to be heard, upon request, at sentencing, before or after conviction or juvenile adjudication, and at any proceeding where the accused's release from custody is considered; the right to restitution from the accused; and the right to be informed, upon request of the accused's escape or release from custody before or after conviction or juvenile adjudication.



Commonly Used Terms / Phrases:

Below are some commonly used terms / phrases that you may see and / or hear when DOC staff contact you verbally or in writing:



Absconder:

An absconder is an offender who has failed to report for a supervision meeting and a warrant has been issued for their arrest.

• <u>Community Residential Center (CRC):</u>

A structured residential setting in the community designed to facilitate the reintegration of offenders back into society with varying levels of supervision and services provided as determined by offender needs and locational constraints.

<u>CourtView:</u>

CourtView is a resource where you can view any individuals legal matters for the State of Alaska. This includes past, current and future court dates and cases. CourtView can be found online at:

• Electronic Monitoring (EM):

This type of monitoring allows offenders who meet certain requirements to serve time at home and / or to be monitored via electronic monitoring equipment.

Home Confinement (HC):

This type of monitoring allows offenders who meet certain requirements to serve time at home while being monitored with or without electronic monitoring equipment depending on their geographic location.

Informal / Open Court Probation:

A type of probation where there is no direct supervision. Instead the offender is monitored by the District Attorney's Office under conditions that are imposed by the court.

Offenders sent outside of Alaska for supervision by probation / parole officers in the state they are transferred to. DOC Probation / Parole Officers provide similar services for offenders sent to Alaska from other states.

Parole:

Parole is the release of a prisoner before their jail sentence has expired. The offender will be supervised by a DOC Parole Officer. Parole provides for the reintegration of the offender into the community, subject to conditions set by the Parole Board. Types of parole include: Administrative; Discretionary; Medical; Geriatric and Mandatory Parole. Contact a Parole Officer for more details.

Pre-Release Furlough:

A placement at a CRC / residential treatment center prior to the firm release date that allows for the reintegration of the offender into society for the purpose of continued educational training, employment, and / or treatment.

Pretrial Services:

Pretrial services offers an option to the court which enhances public safety through monitoring of defendants who release to the community during the pretrial phase. The Division of Pretrial provides risk assessment reports to the court, community supervision, electronic monitoring and diversion services for pretrial defendants

Probation:

When an offender is sentenced for a felony offense, the judge can order the offender be placed on DOC probation supervision. This places the offender in the com-

munity, after release from incarceration.

Probation / Parole Officer (PO):

In Alaska a Probation / Parole Officer are one and the same. These officers are responsible for all supervision activities involving conditions that are imposed by the court or the Parole Board.



Release Date:

The date on which an offender is scheduled to be released from custody, determined by court order or the Parole Board.

Short Duration Furlough:

An authorized leave of absence from confinement for a designated purpose and period of time. Furloughs may be granted for various reasons including medical and compassionate reasons.
