Section 1: Significant Incidents

Case AR24-006414

On April 15, at approximately 3:47 pm, officers were dispatched to an injury crash involving three vehicles near the 6800 block of Carr St.

Officers and Arvada Fire arrived on scene and located an injured adult female in the passenger seat of one of the vehicles. The victim was transported to the hospital with serious but non-life threatening injuries.

Officers learned that the driver of that vehicle walked away from the scene and searched the area for her. The driver was located and arrested. She was jailed on two active warrants and received a summons for hit and run involving bodily injury, careless driving causing injury, and driving on a suspended license.

On April 19, at approximately 1:10 pm, officers were dispatched to a robbery at a business near the 8000 block of Sheridan Blvd. An employee reported a homeless male pointed a knife at them and demanded money from the cash register.

Officers searched the area but the suspect was not located. This case remains under investigation.
