# Section 1: Significant Incidents

#### Case AR24-010353

On June 21, 2024, at about 9:46pm, officers responded to a physical disturbance involving 30 people near Miller St and W 64th Ave. A caller stated there was a gun involved. Officers arrived and began breaking up several fights. A suspect with a gun was identified and taken into custody. The suspect's vehicle was searched and a total of three handguns, a short barrel assault rifle, and high capacity magazines were recovered. The suspect was jailed at Jefferson County Jail on multiple charges including felony menacing, possession of an illegal weapon, possession of high capacity magazines, resisting arrest, obstruction and disorderly conduct.

#### Case AR24-010272

On June 20, 2024, at about 2:48pm, officers were dispatched to the Park Terrace Apartments for a report of three missing children. Their babysitter was caregiving for a client at the apartments, when she noticed the children were no longer playing at the playground. Officers and detectives searched the apartment complex and park extensively but the children were not located.

At Arvada PD's request, the Colorado Bureau of Investigation issued an endangered missing alert for the children. The investigation continued to provide leads, and attempts to locate the children and ongoing interviews with family members continued throughout the night. On the following morning, June 21, around 8:00am, Arvada PD was notified that the children were taken to Denver PD District 4 by a grandparent. The children were picked up by Arvada PD detectives and found to be safe and in good health. The children were later released to a guardian and the case remains under investigation.

#### Case AR24-010258

On June 20, 2024, at about 12:20pm, officers responded to a robbery at Walgreens located at 6395 Sheridan Blvd. The suspect fled on foot prior to officers arriving on scene. Officers learned that a female suspect told a cashier that she had a gun and demanded money from the cash register.

Westminster PD responded and assisted Arvada PD in searching for the suspect. A K9 team was also utilized but the suspect was ultimately not located. The suspect was described as a white female, approximately five feet tall and wearing all black, including a black zip up hooded sweatshirt and a face mask. This case is under investigation.
