### MEMORANDUM OF AGREEMENT

This agreement entered into this 1<sup>st</sup> day of January, 2009 by the **Arlington** County Sheriff's Office and the Arlington County Police Department.

WITNESSETH that the Arlington County Sheriff's Office and the Arlington County Police Department, in consideration of premises and of the mutual covenants, considerations, and agreements contained herein, agree as follows:

**SCOPE OF SERVICES:** The Arlington County Sheriff's Office will provide the Arlington County Police Department with the following services:

To ensure that the Nursing staff contracted by the Arlington County Sheriff's Department is aware that blood draws from suspects are acceptable in cases of blood exposures to Police Officer's based on Virginia Code Title 32.1-37.2. This code allows law enforcement Officers to collect blood in exposure cases if appropriate consent forms are signed by the suspect. When a suspect is in the custody of the Sheriff's Department, the Nursing staff may draw the suspect's blood and release it to an Arlington County Police Officers. The blood will immediately be brought to a designated County contracted location for screening.

#### PERIOD, MODIFICATION, and TERMINATION;

This MOU will take effect immediately upon the date of its execution by the Arlington County Sheriff's Office and the Arlington County Police Department. This MOU will be subject to termination upon sixty (60) days written notice by any of the parties. This MOU may be renewed or modified upon written consent of all the parties.

#### POINTS OF CONTACT:

The primary point of contact for the Sheriff's Office will be the Director of Corrections and the primary contact for the Police Department will be the Safety Officer. Any point of contact may be changed by written notice to the other parties from the agency changing its own point of contact. The change of a point of contact does not require consent of the other parties.
