OBJECTIVES

Facilitated discussion to identify the importance of a thorough and effective search.

Members will demonstrate effective pat downs and quadrant pattern searches of a suspect.

Members will identify and explain procedures for searching vehicles before and after transporting a suspect.

Facilitated discussion to explain why an adult and a juvenile offender should not be transported in the same vehicle.

Members will identify and explain protocols for the strip search of a suspect.



SAFETY OF OFFICERS, DETAINEES, AND MEMBERS OF THE PUBLIC

BEFORE transporting or placing suspects into the wagon, make sure they are properly searched. (Policy 1114)

MEMBERS will ensure the safety of a detainee when a person is taken into custody at all times



TRANSPORTING PRISONERS

The detainee is **secured** with the provided seat belt or restraining

Do NOT transport juveniles in prisoner transport wagons unless they are charged or will be charged charged with a delinquent act Policy
1202

ALL passengers, <u>regardless of age</u> <u>age and seat location</u>, shall be restrained by seat belts or other authorized restraining devices. • Policy 1114

DUTY TO PROVIDE MEDICAL ATTENTION



INJURED PRISONER

When there is an obvious injury, complaint of injury, or medical attention is requested by any individual, members shall...

Immediately render aid consistent with his/her training and experience

Immediately notify Communicatio ons Unit Request that a medic respond to the scene or transport the individual directly to the the nearest hospital emergency room

Transport officer will search prisoner <u>PRIOR</u> to to taking custody from arresting officer

SEARCHING A PRISONER

Members shall <u>NOT</u> conduct cross-gender searches **unless** exigent exigent circumstances exist.

<u>ALL</u> cross-gender searches shall be documented on a 95 and and attached to the arrestee's file.

(Policy 1013).

TRANSPORT VEHICLE OPERATOR RESPONSIBILITIES



Inspect the transport vehicle vehicle for any property prior prior to placing the detainee detainee inside.



Inspect the transport vehicle vehicle again after the detainee is removed from the the vehicle.



If any contraband and/or CDS CDS are found in the transport transport vehicle, the transporting officer will recover recover them.

(Policy 1401, Policy 1402)

OPERATOR RESPONSIBILITIES FOR ALL VEHICLES

1. Turn on BWC (BODY WORN CAMERA)

2. Conduct a function check to ensure the TVC is operating properly.

3. Ensure the ignition is turned on and the TVC is recording whenever a subject is inside of a transport vehicle.

4. "Mark" video data when an individual in custody enters the prisoner holding area of the vehicle.

5. "Mark" video data when an individual in custody exits the prisoner holding area of the vehicle.

6. Transport all individuals as directed by Policy 1114, Persons In Police Custody

STRIP SEARCHES (POLICY 1013)

<u>Definition</u>: The removal or rearrangement of clothing to permit the visual inspection of any or all skin surfaces including the genital areas, breasts, and buttocks.

STRIP SEARCHES (POLICY 1013)

Requires the approval of a Lieutenant or

Must be conducted in **privacy**, preferably preferably in station.

Requires RAS or probable cause

Will be conducted by the **fewest** number number of personnel necessary.

STRIP SEARCHES (POLICY 1013)

Officer will explain to subject the reason.

Officer will give the subject opportunity to voluntarily produce produce the suspected item.

Subject will only be allowed to voluntarily produce the item if item if safety will not be compromised.

Only conducted by members of same gender.

No cross gender witnesses.


STRIP SEARCH (POLICY 1013)

Officers will ask subject subject on camera if they wish for the search search to be recorded recorded on BWC.

Officers will comply with subject's decision. decision. BWC will be activated activated immediately immediately following following conclusion of of the strip search.

FLEX CUFFS

- Flex cuffs are one time use only.
- Only use proper cut shears to remove flex cuffs.
- Do not use knives to loosen or remove flex cuffs.



CONTROL HOLDS



SPIT SHIELD/ SAFETY GLASSES



COMPLIANCE/ INSPECTION UNIT

Only work-related phone calls can be taken while operating a transport vehicle. Personal calls / texting is prohibited.

Seek the safest and shortest course to your destination

Do not exceed speed limit with prisoner on board.

Stay with your prisoner to monitor, don't leave your prisoner unattended.

When individuals in custody refuse medical treatment, you must request medic. Mark suspect in and out via

(TVC)

Be mindful of aggressive or hard braking.

More officers in patrol vehicles are failing audits then officers Wagons.
