# EXTREME RISK PROTECTION ORDERS

## What is an Extreme Risk Protection Order?

An extreme risk protection order (ERPO) is a civil restraining order prohibiting the named individual from controlling, owning, purchasing, possessing, or otherwise having custody of any firearms.

This order was issued by a judge. The Colorado Springs Police Department cannot provide legal advice about this process. For additional information and forms, please visit the Colorado Judicial Branch website at <https://www.courts.state.co.us>, or visit any Court Clerk's Office in Colorado.

**Please note:** this order is not the same as a civil protection order that may prohibit contact and/or restrain a person from a person or place. A request for this type of protection order can be made following a different process that is also described at the Colorado Judicial Branch website.

## How do I voluntarily surrender firearms?

If you are the named individual in the Extreme Risk Protection Order (called a "respondent") you may choose to voluntarily surrender your firearms and concealed carry permit at the Colorado Springs Police Operations Center at 705 S. Nevada Avenue or a patrol substation.

1. Come unarmed to the police department.
2. Do not bring ammunition or magazines with you. They do not need to be surrendered.
3. Leave your firearms **unloaded** and **out of sight** in a **locked** vehicle while you come in.
4. Tell the person at the front desk that you need to voluntarily surrender your firearms and concealed carry permit (if applicable) because you are the respondent in an Extreme Risk Protection Order.
5. An officer will collect the firearms and any concealed carry permit.

## How do I get my firearms back?

When the order that prevents you from having firearms and a concealed carry permit has expired or has been terminated by a judge, **it is your responsibility to contact CSPD** to arrange for picking up your property.

1. Contact the Evidence Unit to make an appointment.

**You will only receive your property back by making an appointment. Walk-in pickups are not allowed.**

2. On the date and time of your appointment, arrive at the CSPD Property Return at 224 E. Rio Grande St.
  - Bring a valid photo id
  - Check in at the front desk.

**REMINDER:** Keep your address and other contact information up to date with the Evidence Unit while CSPD has your property.
