The Department has created a training and evaluation program for newly promoted sergeants based on the Field Training Officer Program. The purpose of the program is to train, assist, and evaluate newly promoted sergeants during their probationary period.

The Field Training Sergeant Pilot Program Procedure is effective immediately. The pilot procedure is available through the **Power DMS** portal. Personnel should review the pilot procedure in its entirety.

2. REVISION TO PROCEDURE 12.113, RIGHT OF ENTRY STICKERS AND RIGHT OF ENTRY LETTERS

Procedure 12.113, Right of Entry Stickers and Right of Entry Letters, has been revised to reflect the annual letter verification by the affected district's Neighborhood Liaison Officer. This is conducted to ensure the contact information of the owner/manager and emergency or night phone number are valid.

This revision is effective immediately. Personnel should review Procedure 12.113 in its entirety. The revised procedure is available through the **Power DMS** portal.

3. NON-AUTHORIZED OPEN-TOP MAGAZINE HOLDERS

Personnel are reminded to adhere to Procedure 12.020, Uniforms, Related Equipment, and Personal Grooming. The "Policy" section of the procedure specifically states: ***"Sworn personnel will only wear uniforms and equipment issued or approved by the Cincinnati Police Department (CPD) or approved by the Police Chief."***

Police Supply has had to replace two exterior vest carriers due to damage caused to the front panel. Additionally, other exterior vest carriers have been observed showing signs of similar excessive wear/damage. This damage appears to be caused by use of unauthorized open-top magazine holders on the duty-belt, in lieu of the Department issued leather double magazine holder or approved nylon magazine holder. The open-top magazine holder is allowing the magazines to rub directly against the fabric of the carrier, causing the damage.

Officers shall only utilize the Department approved magazine holders when in uniform, in compliance with Procedure 12.020.

4. CPD IS PARTICIPATING IN "NO SHAVE NOVEMBER"

No-Shave November is a month-long event, in which participants forgo shaving to spark conversation and raise cancer awareness. CPD is participating in hopes of educating employees and the community about cancer prevention.

Participation is open to all Police Officers, Police Specialists, and Sergeants, as well as civilian employees. For those employees who do participate in No-Shave November, the current beard grooming standards established for exemptions contained in Procedure 12.020, Uniforms, Related Equipment, and Personal Grooming, must be followed.

Although it does not cost anything to participate, donations to the American Cancer Society are strongly encouraged. CPD has a handful of officers, current and retired, who are fighting their own cancer battles and every donation helps to fight cancer and support them in their battle.

5. REMINDER TO OFFICERS REGARDING WANTED SUBJECTS

The Department's Terminal Agency Coordinator (TAC) reminds all officers running a subject that returns with wants, to ensure the MIS field in the return is carefully read prior to contacting CIN1 for a Hit Request. A wanted subject showing a Pick-Up-Radius of 1 (full extradition) could contain actual distance requirements entered in the MIS field that may or may not impact extradition.

No-Shave November Guidelines

The main purpose of No-Shave November campaign is for men to embrace their hair that most cancer patients lose while undergoing chemotherapy.

Officers are encouraged to donate a minimum of \$50.00 to a charity chosen by the Chief to participate in No-Shave November.

Guidelines

“Facial hair: No facial hair shall exceed 1/4 inch in length. If the individual cannot grow a full or thick beard or goatee, then they will be prohibited from wearing such.

Facial hair is permitted if maintained in a neat and clean manner that presents a groomed appearance. Patchy, spotty, inconsistent, or sparse facial hair will not be permitted.

1. Deliberate stylings or designs are not authorized.
2. Employees may not wear a beard or goatee without a mustache.
3. Facial hair may not exceed one quarter inch in length and the neck area below one's Adam's apple must be clean shaven.
4. Mustaches may not extend over the lip, or when worn alone, beyond the corner of the mouth more than one half inch in any direction.

Beards: Beards may be worn as long as the beard is kept at the proper length trimmed on a regular basis and has a clean-shaven edge around the top of the beard and below the beard. The neck will be clean-shaven.

Goatees: Goatees may be worn as long as the goatee is kept at the proper length trimmed on a regular basis and has a clean-shaven edge all around the goatee. The neck will be clean shaven.”

Mustaches: A neatly trimmed mustache is acceptable provided the following standards are strictly adhered to the mustache cannot turn upward or downward at the end. (No “Fu Manchu” or “handlebar” styles.) The mustache cannot be worn twisted or waxed on the ends. The mustache must be completely off the top of the upper lip. The mouth must be totally exposed. The mustache cannot be worn so thick that extended outward over 1/2 inch at any point. The width of the mustache may not exceed 1/4 inch maximum at any point. The mustache cannot extend beyond the corner of the mouth by 1/4 inch in length. The mustache cannot be dyed or worn any color different from the hair.

Sideburns shall not extend below 3/4 of the length of the ear and shall end with a clean-shaven horizontal line. The maximum width at the bottom of the sideburns shall not exceed 1” (no “lamb chops”).




