1. REVISION TO PROCEDURE 12.910, MISSING PERSONS

Procedure 12.910, Missing Persons, has been revised to reflect the addition of directives designed to correct deficiencies occurring with the reporting of missing juveniles, as well as incomplete investigations in regard to the cancellation reports.

When officers call in a missing person to Teletype, they need to provide the Teletype operator with all the pertinent information they have regarding the missing person (i.e.: diagnosis, meds they could be on, if they are on drugs, if they have attempted suicide or could be suicidal). This information is being put into the investigative notes but is not being provided to Teletype when the missing person is called in. Teletype is unable to see the investigative notes, therefore the officer must verbally communicate the information (any diagnosis, on meds, on drugs, suicidal, etc.) regarding the missing person to Teletype.

Additionally, a thorough and complete investigation **must** be conducted in reference to the cancellation of a missing juvenile. Simply speaking with the reportee and not responding to the location to physically verify the return and condition of the missing juvenile is **NOT** acceptable.

Per Procedure 12.910, Section H.2., officers need to physically see the juvenile prior to canceling the report:

2. *If the located missing person is a juvenile, conduct a follow up investigation.*
 - a. *Attempt to determine where and with who the juvenile has been.*
 - b. *Speak with the juvenile and look for physical signs of abuse or neglect.*
 - 1) *If there are allegations or physical signs of abuse or neglect, conduct/complete the appropriate investigations.*

This revision is effective immediately. Personnel should review Procedure 12.910 in its entirety. The revised procedure is available through the **Power DMS** portal.

2. REVISION TO PROCEDURE 19.103, MILITARY LEAVE

Procedure 19.103, Military Leave, has been revised to reflect current processes. The Military Family Support Program (MFSP) is now referred to as the Military Liaison Group (MLG). The MLG will coordinate Extended Military Leave processes with Police Personnel and ensures the employee understands their rights and responsibilities as it pertains to their service, benefits, and pay while deployed.

Military Leave is separated into three categories.

- 1) Drill weekends (2-5 days),
- 2) Short Term or Active-duty Training (ADT) Leave (up to 60 days)
- 3) Extended Military Leave/Deployment Leave (more than 60 days)

Officers called to Extended Military Leave for more than 60 consecutive days must turn in all Department issued equipment, except their Department issued identification card and badge to Police Supply. Firearms must be turned in and stored at the Target Range. The items will remain stored until the officer's return from active duty.

This revision is effective immediately. Personnel should review Procedure 19.103 in its entirety. The revised procedure is available through the **Power DMS** portal.

3. REVISION TO PROCEDURE 16.112, MANDATORY OFF DAY DEVIATION AND VOLUNTARY SHIFT DEVIATION

Procedure 16.112, Mandatory Off Day Deviation and Voluntary Shift Deviation, has been revised to reflect current Kronos Workforce Management System processes.

The procedure has been renamed "Mandatory Shift and Off Day Deviation and Voluntary Shift and Off Day Deviation." Language has been added to clarify current processes.

This revision is effective immediately. Personnel should review Procedure 16.112 in its entirety. The revised procedure is available through the **Power DMS** portal.

4. REVISION TO PROCEDURE 12.205, TRAFFIC ENFORCEMENT, AND PROCEDURE 12.555, ARREST / CITATION: PROCESSING OF ADULT MISDEMEANOR AND FELONY OFFENDERS

Procedure 12.205, Traffic Enforcement, and Procedure 12.555, Arrest/Citation: Processing of Adult Misdemeanor and Felony Offenders, have been revised.

- New language has been added addressing what personal information is required by law, when requested by a law enforcement officer.
- By Ohio law, the only personal information a pedestrian is required to give is, name, address, or date of birth.

- Ohio Revised Code 2921.29, Failure to Disclose Personal Information, has been added to both procedures under references.
- Cincinnati Municipal Code Chapter 515-2, Parking Infraction Not a Criminal Offense, has been added to Procedure 12.205.
- Officers may not arrest a subject because of a parking citation, except for offenses committed during or after the writing and/or issuance of a parking citation, i.e., Obstruction of Official Business, Disorderly Conduct.

The revisions are effective immediately. Personnel should review Procedures 12.205 and 12.555 in their entirety. The revised procedures are available through the **Power DMS** portal.

6. CITIZEN COMPLAINANT CRIMINALLY CHARGED WITH FALSIFICATION

Internal Investigations Section (IIS) personnel completed a review of a Citizen Complaint of a Serious Misconduct Violation filed by Ms. Crystal Green. Ms. Green alleged three Cincinnati Police Officers engaged in serious misconduct that was sexual in nature.

The investigation by IIS personnel determined the allegations to be false. The Body Worn Camera (BWC) system and the Digital Video Recorder (DVR) were helpful in reaching this conclusion. IIS personnel filed three criminal charges against Ms. Green for Falsification, Section 2921.13 (A)(2) Ohio Revised Code.

7. CPD SUPPORTS NATIONAL BREAST CANCER AWARENESS

October is National Breast Cancer Awareness Month.

In support of National Breast Cancer Awareness Month, Interim Police Chief Teresa A. Theetge has authorized the wearing of the following uniform parts by officers to bring awareness to this worthy cause and to support those battling cancer:

- Officers who have purchased pink badges may wear them on their duty uniform.
- Officers who have purchased Breast Cancer Awareness patches from the FOP may sew them on one uniform.
- Officers may wear the National Breast Cancer Awareness CPD ballcap if they have one, in lieu of wearing the required uniform hat.
- Interim Chief Theetge has authorized the wearing of these items beginning **Saturday, October 1**, through **Monday, October 31, 2022**.

I wish to extend my thanks and official commendation to you for the following:


On August 3, 2022, at approximately 0312 hours, an Aggravated Burglary offense occurred at 794 Delhi Avenue, during which three armed suspects entered the victim's residence while her two children were present, demanded property at gunpoint, and subsequently shot the victim in the face. Police Sergeant Mike Miller and Police Officer Alexander Gettys of the District Three Investigative Unit and Police Officer Brandon Connley of the District Three Violent Crimes Squad responded to conduct the investigation, interviewing the victim and witnesses and processing the crime scene.

At approximately 1034 hours, while on patrol in the area, Police Specialist Doug Smith of District Three obtained information from a resident of the neighborhood that the suspects involved in the offense at 794 Delhi Avenue were inside the residence at 634 Steiner Avenue, and requested additional officers respond to assist. Police Sergeants Donald Elsaesser and Gregory Vollner and Police Officers Kevin Osuna, Joshua Jordan, Emmett McFarland, and Rayshawn Maye of District Three, and Police Officer Sean Woods of Canine Squad, responded to the address to assist.

Sergeant Vollner and several officers established a perimeter while Sergeant Elsaesser formed a search team with the remaining officers, locating the suspects in the basement of the residence and taking them into custody without incident. Sergeant Miller responded to the scene with Officer Connley, Police Specialists Les Mendes and Jerry Turner, and Police Officers William Trabel, Merredeth Newman, Jacob Wloszek, Doug White, Regina Williams, Ken Vanderpool, and Bryan Delk of the District Three Investigative Unit. Investigators obtained consent to conduct a further search of the residence, as well as a suspect vehicle located on the scene, resulting in the recovery of three loaded handguns used in the offense at 794 Delhi Avenue. The three suspects involved in the offense were each interviewed by investigators and charged with Aggravated Burglary and Felonious Assault.

You are commended for your dedication to duty, tactics, investigative skill, and leadership, which directly contributed to the recovery of three firearms used in this offense and the removal of three violent felons from the streets of Cincinnati.
