What is the overall deductible?	Clarinda Regional Health Center: \$1,650 person/\$3,300 family per calendar year. In-Network (IN) Provider: \$2,500 person/\$5,000 family per calendar year. Out-of-Network (OON) Provider: \$2,500 person/\$5,000 family per calendar year.	Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your deductible?	Yes. Well-child care and in-network preventive care are covered before you meet your deductible.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. Does this plan provide Minimum Essential Coverage? Yes
