PRIMARY FUNCTION:

The Emergency Department Technician (EDT) is responsible for providing basic technical patient care skills under the direction and supervision of the Registered Nurse (RN). Supports the Emergency Department professional clinical staff by providing direct patient care, performing phlebotomy functions, EKGs and assistive skills on all age groups: neonate, infant, child, adolescent, adult and geriatric as assigned by the provider or RN. Performs clerical work and coordinates communications within the unit. Facilitates the information exchange process between the nursing area and other hospital departments. Responsible for ADVANCING EXCEPTIONAL CARE through the implementation of policies, protocols, and practice guidelines; participating in rigorous performance improvement monitoring and staff education.

1.	Works with and assists Providers and Nurses and provides technical support for patient care
2.	Reports on the condition of the patient to the appropriate supervisor and other staff members
3. 4.	Cleans and stocks carts, rooms, and changes linen, as required. Cleans room (changes linens on carts, cleans equipment, and removes disposable items, and wipes down counters and sinks) in preparation for the next patient. Assist with the transport of patients to other departments if appropriate
5.	Performs tasks including positioning and maintaining patient in correct and safe alignment; measuring and recording temperature, pulse rate, respiratory rate and blood pressure; measuring and recording height and weight, intake and output, as directed and communicating results with RN

6.	Performance of 12 lead EKGs
7.	Performs phlebotomies and blood glucose
8.	Collects and accurately labels various specimens, including urine and venous blood specimens.
9.	Performs or assists patients with personal hygiene such as oral care, dressing/undressing and elimination needs. Assist patients to bathroom/bedside commode/peri care if applicable
10.	Answer call lights as appropriate
11.	Assist with positioning patients, assist applying orthopedic dressing and splints
12.	Answers phone, takes messages and communicates to the appropriate person
13.	Assists with collecting patient information to send with transfer/discharge, faxing/ calling for providers for transfer availability once found transferring to provider
14.	Coordinates with staff to meet established quality standards
15.	Assist Triage Nursing in meeting the needs of individuals in the waiting area, with vitals, rooming patients, and helping get patients out of car.
16.	Assists RN with arrival of EMS patients
17.	Rounding every 30 minutes or sooner on patients and meeting their needs or communicating them to the RN
18.	Performs or assists with CPR.
