# **MISSING PERSONS**

**ACTION:** Amends general order dated October 1, 2022.

# 08.07.0 PURPOSE

The purpose of this general order is to establish guidelines for the investigation and handling of reported missing persons.

## 08.07.1 POLICY

It shall be the policy of the Concord Police Department to respond to and thoroughly investigate all reports of missing or unidentified children and adults.

#### 08.07.2 DEFINITIONS

#### A. CRITICAL MISSING PERSON

To be classified as a critical missing person, an individual that has been reported missing must meet AMBER Alert, Ashanti Alert or Missing Endangered Alert criteria or, at least one of the following criteria:

- 1. The individual has a physical, mental, or cognitive disability (Dementia or Alzheimer's), drug dependency or other at-risk issues, which subjects them or others to danger.
- 2. There is reasonable suspicion to believe the disappearance of the individual is not voluntary and/or the person is the victim of a crime.
- 3. The individual has a medical condition that requires life-saving medication or procedures, and it is believed the individual does not have access to those necessities.
- 4. The individual is missing after a disaster, but not confirmed to be dead (e.g., drowning, explosion).
- 5. The individual is 13 years or younger, regardless of the circumstances.
- 6. The individual is under the age of 18 and has their own minor child in their custody.
- 7. An individual believed to be in the presence of someone who could endanger their welfare.

# MISSING PERSON

#### B. TEMPORARY CUSTODY (JUVENILE)

The taking of physical custody and providing personal care and supervision until a court order for secure or nonsecure custody can be obtained.

#### C. MISSING JUVENILE

A juvenile as defined by <u>NCGS 7B-101(14)</u> whose location has not been determined, who has been reported missing to a law enforcement agency by a parent, guardian or legal custodian.

#### D. MISSING PERSON

Any individual who is 18 years of age or older, whose location has not been determined, and who has been reported missing to a law enforcement agency.

E. NATIONAL MISSING AND UNIDENTIFIED PERSONS SYSTEM (NamUs)

A national resource center for missing, unidentified and unclaimed persons.

F. RUNAWAY JUVENILE

An individual, age 17 years or younger, who has voluntarily left the custody of their parent, guardian, or legal custodian without permission.

#### 08.07.3 MISSING PERSON PROCEDURES

- A. An incident report shall be taken as soon as an individual is confirmed missing by an officer.
- B. Once the individual has been confirmed missing, the officer shall gather as much pertinent information as possible to accurately classify the individual and initiate the appropriate response. This should include, but is not limited to, the following information:
  - 1. Physical Description:
    - a. Name, date of birth, race, sex, ethnicity, height, weight, build, hair and eye color;
    - b. Facial hair, glasses, teeth, scars, marks, tattoos, piercings, amputation or other physical characteristics;
    - c. Description of clothing such as head cover, shirt, pants, outerwear, footwear, jewelry.
  - 2. Reporting Factors:
    - a. Location last seen, last seen with, date and time last seen;
    - b. Name of the reporting person and their relationship to the missing individual;
    - c. If the individual has previously been reported missing and where they were previously located;

- C. The Missing Person/Runaway report section in RMS shall also be completed with the necessary information.
- D. Upon completion of the Incident Report, a supervisor shall be contacted immediately to review and approve the report.
- E. The investigating officer shall provide a copy of the report to the Customer Service Unit DCI operator for entry into DCI as soon as possible.
- F. When a missing or unidentified person or child case is active for over 90 days, the investigating officer shall enter the subject's information into the NamUs database (<u>https://namus.nij.ojp.gov/</u>).

## 08.07.4 NCIC ENTRY/REMOVAL

- A. Individuals reported missing, regardless of age and missing under any circumstances, shall be entered into NCIC within two (2) hours of the basic information necessary for entry being obtained. The two (2) hour period begins when the basic information is received, not when the report is submitted for approval.
- B. When the missing person is located then the individual shall be cleared out of NCIC (if entered) **without delay.** If a statewide "Attempt to Locate" message was previously transmitted, a locate message shall be routed statewide using the same routing list.
  - 1. A supplement shall be completed to include that the person was located along with the location and any other information that is pertinent to the investigation.

#### 08.07.5 DISSEMINATION OF INFORMATION

- A. Upon completion of the NCIC entry, Customer Service coworkers shall broadcast the entry via a DCI 50-mile radius message.
- B. At the request of the watch commander, the Communications Center supervisor can authorize a broadcast to all police units (BOLO) regarding information on the missing individual at any time during the investigation.
- C. The watch commander may authorize a media release should exigent circumstances exist.

#### 08.07.6 INVESTIGATIVE PROCEDURES

- A. The first officer on scene shall be assigned to conduct the initial and follow-up investigation for every type of missing person to include:
  - 1. Conduct a consent search of the home and grounds from which the individual went missing.
  - 2. Search of the last location the missing person was seen and interview those who last saw the individual.

8. If the NCIC entry has not been made, the Communication Center may be requested to send pertinent information regarding the juvenile to other agencies via a DCI message.

#### C. CRITICAL MISSING PERSON

The first responding officer to a critical missing person report shall conduct an investigation in accordance with this general order and include the following:

- 1. A supervisor shall coordinate a second search and re-search of the home and property as well as a canvas of the surrounding area.
- 2. At the request of the watch commander, the Communications Center supervisor should be contacted to a broadcast to all Concord Police Department on duty personnel coworkers (BOLO) pertinent information on the missing individual at any time during the investigation.
- 3. If the NCIC entry has not been made, the Communication Center may be requested to send pertinent information regarding the individual to other agencies via DCI message.
- 4. The on-call investigations supervisor shall be notified by the watch commander of all critical missing persons.
- 5. Evaluate whether the circumstances of the missing person's disappearance meet the criteria for an alert system as outlined in General Order 08.10 Alert Systems and/or other immediate community notification protocols.
- 6. Any investigation of a critical missing person shall continue until the person is located, the incident has been passed to another officer for follow-up, or all reasonable investigative measures have been completed to the satisfaction of the Criminal Investigations Division captain or higher authority.

#### D. RUNAWAY JUVENILES

- 1. Local Runaway Juveniles
  - a. Local runaway juveniles may be taken into temporary custody, in accordance with NCGS 7B-1900 and General Order 07.07 Juvenile Operations and returned home.
  - b. If the juvenile's parent, guardian or custodian can't be contacted or it takes more than 12 hours on weekdays or 24 hours on weekends and holidays (NCGS 7B-1901), a secure order can be obtained and the juvenile placed in a detention facility. These time limitations are designed to comply with federal law prohibiting the detention of non-delinquent juveniles in secure facilities.
  - c. The on call DSS worker shall be contacted when a juvenile can't be returned to their parent, guardian or custodian within the allotted time period.
- 2. In-State Runaway Juveniles
  - a. In-state runaways may be taken into temporary custody (NCGS 7B-1900) The officer shall contact the juvenile's parents, guardian or custodian to pick

If a juvenile meets the following criteria of a chronic juvenile runaway, the investigating coworker should seek an undisciplined juvenile petition through the Division of Juvenile Justice.

- a. Meet the criteria as an undisciplined juvenile as set forth in NCGS 7B-1501(27);
- b. Two or more incident reports listing the juvenile as a run-away within six months and was missing for 24 hours or more during each incident;
- c. Has a history of undisciplined behavior (i.e. truancy, drug/alcohol abuse, gang activity).

#### B. ABANDONED/UNIDENTIFIED CHILDREN

Occasionally, officers respond to calls of children being left unattended or abandoned. Officers should coordinate a response with the Department of Social Services for assistance in these situations.
