# Sheriff's Office Recovers Stolen Property

On the evening of Monday, September 15, 2025, deputies responded to the report of a burglary in Westport.

- A large amount of firearms and cash, along with other items were reported as stolen from a seasonal residence.

On Tuesday, September 16, 2025, deputies executed a search warrant in Elizabethtown.

- During this search, the stolen firearms and other items were recovered.

- As a result of the investigation and the search warrant results, Deputies have arrested two people:
- Joseph Olds of Elizabethtown
- Brandy Machia of Elizabethtown
  - Burglary 2<sup>nd</sup> [PL §140.25(2)] Class C Felony
  - Grand Larceny 4<sup>th</sup> [PL §155.30(4)] Class E Felony
- Both have been remanded to the Essex County Jail in lieu of \$75,000 Cash Bail.
- ***This is still an ongoing investigation, with additional charges pending***





# ARREST

September 17, 2025

- After reviewing inmate communication by jail staff, Louis Jordon of Ticonderoga was arrested for violating an order of protection by sending correspondence to a protected person. Jordon was arrested for:
  - Criminal Contempt 2<sup>nd</sup> Disobeying a Court Order – Class A Misdemeanor [PL §215.50(3)]
  - He will appear in the Town of Lewis Court at a later date. He remains remanded to the Essex County Jail from the Town of Ticonderoga.
