



# 2001 Annual Report of the Essex County Sheriff Department and Jail



## JAIL

*Jail bookings in 2001:* 435 males, and;  
47 females  
**482 incarcerations.**

## Boarding out

**Cost for overflow inmates for 2001 - \$420,506.00**

(Daily average for 2001 - 15 inmates)

While our boarding days of inmates decreased by 32% from 1999 to 2000, the increase we experienced in the waning months of 2000 continued and the result was 2001 saw a 48% increase in boarded out bed days over 2000.

The actual increase was from 4,143 days in 2000 to 6,145 days in 2001.

\* This is a double murder suspect being in Sullivan County on a court order for their felony court proceedings.

### Female inmates

Female inmates were a large part of the "housing out". 2001 saw **47 female inmates for a total of 1,690 days** - up over 230%.

While our female bookings reflect a small decrease in numbers, the inmates that we did hold were significantly longer in duration than in 2000.

## New Programs

St Joseph's Substance Abuse Program has been active in the facility with the services of Nancy Dawson. She has successfully been running Anger Management as well as substance abuse services. In the short time she has been coming to the jail on a regular basis, she has actively worked with 70 inmates and of these 20 have been referred to treatment facilities after leaving the jail.

It is too soon to effectively evaluate the success of the program on any of these individuals, but should even one not return to the facility, this translates to a savings in bed space of over \$26,000 per year.

## Intermittent Inmates

"Part time" inmates are a continual problem for jails with limited space. In order to allow a defendant to maintain gainful employment or remain in school or college but still satisfy a court ordered sentence, Judges hand down a sentence ordering the defendant to serve specific days in jail and be out for the remainder of the week. While the days to be served can be anything, the most common is reporting to jail on Friday night and serving until Sunday night. These sentences can run up to one year in duration. ***Last year, we had an average of 2 intermittent inmates every weekend with a high of 15.*** This means boarding out enough inmates on Friday to make room for these incoming inmates and then returning "our" inmates on Sunday - entailing transportation and overtime costs for both trips.

### Medical care

As we are legally obligated to "take and safely keep all inmates legally committed", we occasionally have inmates being hospitalized while committed to the Sheriff's custody. This requires 24 hour guarding of the inmate requiring overtime to accomplish.

2001 had 1 Inmate hospitalized for 8 days.

## Inmate Transports

### Court Transports

In 2001, Court, Board and medical transports resulted in the following:

Inmate Housing      274 transports moved 689 inmates;

Justice Courts      158 transports moved 189 inmates;

Medical, Prison,

Etc                    80 transports moved 91 inmates;

### **Grand totals:**

512 transports moved 969 inmates over 65,640 miles requiring 4,890 paid hours of staff time.

## Juvenile Transports

Juvenile transports (under 16 years of age) are always a budgetary drain.

2001: 3 Transports

240 Miles;

20 staff hours.

Most juvenile transports come on a moments notice and can result in transportation to anywhere from a local non-secure detention home to one of the secure facilities anywhere in the state.

## "State Inmates"

State overcrowding is also reflected in our figures as we housed **8 Parole Violators for a period of 391 days** waiting for the return process to be completed and the offender to be returned to the State System. When the jail is full, these extra state inmates cause us to board out. **391 bed days boarded out cost us \$28,152.00 and in return, state reimbursement allows \$13,294.00 for housing these inmates. This is a net loss to Essex County of \$14,858.00.**

State Ready

We also have a problem with the holding of inmates between sentencing to a State facility and the actual transportation to prison. The Department of Corrections is under Court order to take these inmates within 10 days, but due to overcrowding, this deadline is not regularly met. When this happens, we receive \$34.00 per day for housing in excess of the statutory 10-day period.

**Last year, we held 4 over the statutory 10-day limit.**

In 2001, we held **20 State Ready inmates** for a total of **185 days**. In the same scenario as Parole Violators, these beds cost us \$13,320.00 in board out costs while reimbursement was \$6,290.00 leaving a **deficit of \$7,030.00**.

### Convicted Felons Sentenced to the County Jail

Another area of "State" inmates in the county jail is an inmate convicted of and sentenced for a felony, but sentenced to a term of 1 year or less. This results in the inmates doing their time in the county jail without state reimbursement. In 2001, we had **59 of these inmates for a total of 4,818 days** of housing after their sentences. These days, **if** boarded out would cost \$346,896.00. This is a total loss to the county as the previous \$17.00 per day reimbursement was eliminated last year. Should this reimbursement have still been in place, the total claimed would be \$81,906.00.

## Jail Incidents & Discipline

Operating any detention facility is a risky job to the employees. Essex County Jail expects the inmates committed to the jail to live by certain rules and regulations for the safety, security and good order of the facility.

Last year, we had 14 offenses serious enough for formal written Disciplinary charges as well as innumerable minor offenses handled by the officers.

Of these 10 were offenses involving contraband, fighting, unruly behavior, etc.

We only had one incident serious enough for mandated reporting to the New York State Commission of Correction. This involved an inmate attempting to open an aged, sticking door and falling. He claimed a back injury and was treated at the local hospital and returned to the jail.

## VINE

### (Victim Identification and Notification Everyday)

This program allows anyone to call a toll free number and determine if an offender is in a county jail, NYC lockup or state prison in New York State. If so, the caller can request notification upon the offender's release. Within 15 minutes of the offender's release, the computer will place a call notifying the interested party of the release. This is a completely anonymous computerized service and is free to the user.

While this system is designed for the victim, anyone can utilize the system - District Attorneys, police, press, defense attorneys, courts, virtually anyone with the name of an offender and the interest in knowing the release date.

Through this grant, we are able to provide posters, pamphlets, instructional videotapes, etc to all police agencies in Essex County as well as agencies such as End Domestic Violence, Probation, Mental Health, Hospitals, all courts, etc.

During 2001 this system made 14 release notification calls to victims/interested parties.

## DNA Indexing

New York State has implemented a system whereby certain felony offenders are required to provide a blood sample for DNA indexing. This is to build a database of convicted offenders for future reference where DNA trace evidence is left at a crime scene. During 2001, New York State developed a program whereby collecting blood from offenders was replaced by a buccal swab. This method involves a sponge like swap being utilized inside the offender's mouth and the cells collected then being transmitted to the lab.

Since its inception, New York State has received 94,658 collections of DNA and has had 128 "hits" whereby an offender was identified as being present at a crime scene through a match of DNA.

Through this program in 2001, Essex County Jail has identified 9 target convicted offenders in our jail and have harvested and forwarded the necessary biological evidence to the state for inclusion in the register. This brings Essex County's contribution to the register to 30 since the inception of the program.

## Facility Nurse

In order to better provide medical care for our inmates, to assist Dr. Herbert Savel and to comply with state requirements, Mary Murphy oversees the medical delivery inside the facility.

Ms. Murphy continues to make a significant impact on services in the jail. Her duties include, but are not limited to:

- testing all inmates for TB;
- medical screening of all incoming inmates;
- supervision of inmate medications;
- oversight of regular "sick call";
- supervision of special medical needs inmates such as diabetics, cardiac patients, post surgical, etc.;
- training of staff in medical areas;
- annual testing of staff for TB;
- inoculation of staff for flu, hepatitis, etc prevention, and;

- work closely with Dr. Savel to insure adequate medical services are provided to the inmate population, thereby reducing liability of the facility.

We are seeing a significant improvement in medical care to inmates primarily in screening of new inmates for medical, mental health and substance abuse cases as well as being referred to appropriate treatment programs to help defer recidivism in these problem areas.

Also with a trained professional working full time in the medical office we are able to better keep a handle on our medication budget through medication management and use of over the counter remedies in place of sometimes very expensive prescriptions.

## PATROL

During 2001, this department received 62 **Arrest Warrants** for execution. These warrants were for individuals anywhere in the state or country. As of January 2001, 46 of these warrants were closed through arrests, vacated by the courts or otherwise withdrawn. The 16 outstanding warrants are still in process of locating the defendant/respondents or when located have been filed with other agencies awaiting the defendant to be available for arrest. Some are out of the state or country, others have moved and the whereabouts are unknown, still others are located in other counties in New York State and we are at the mercy of their Warrant Squads to make the arrest and turn them over to us.

Our patrols accomplished 90 **arrests** during 2001. These were Family Court Warrants as well as criminal offenses ranging from felonies down to violations. Our patrols also issued **770 Uniform Traffic Tickets**.

These patrols also investigated numerous motor vehicle accidents. Of these, 13 were serious enough, either in physical injury or property damage to necessitate formal written investigations.

As a police agency, this department also logs incidents. An incident is a term given to any type of complaint, response or action. Our incidents ranged from citizen assists, to stranded motorists, lockouts from cars and houses, prowler complaints, missing children, suspicious vehicles, loud parties, animal complaints, alarms, etc. Also, in these incidents are assists to other agencies such as Police, Ambulance squads and assisting in the search for escapees such as the one from New York State Department of Corrections Shock Camp Moriah and Federal Correctional Institute Ray Brook in past years. The remainders of the incidents range from domestic disputes and family offenses to alcohol complaints, DWI, traffic complaints, Burglary, dangerous drugs, vehicular accidents, etc.

Also included in our duties are security for special events and visits by dignitaries. Some noteworthy events during 2001 were:

- ESPN Great Outdoor Games, Lake Placid;
- ISUZU Ironman Triathlon, Lake Placid;
- Adirondack Marathon, Schroon Lake;
- Salt Lake City Olympic Torch Run;
- Buckle Up New York Road & Safety Checks as funded by grant dollars: May, September and November.

In the wake of September 11<sup>th</sup> Terrorist Attacks and the increased risk of biological threats, our officers have been trained in protocols to be used in handling suspect mail. During the latter part of 2001 our officers handled 7 suspect pieces of mail. All of these proved negative to an active threat, but had they been a risk, they were handled professionally and safely reducing risk of spreading contamination.

## **School Resource Officer Program**

These dedicated officers perform a multitude of services while in the schools. They are counselors, law enforcement resource sources, a police presence, an educator in law enforcement areas and in many cases a "non-interested" third party for students to sound off to and discuss problems they can't take elsewhere. They teach safety issues dealing with the law, firearms and even make time to attend sporting events, after school activities and graduations. From time to time, you can even find our dedicated Resource Officers "dressed down" and playing kickball with elementary students, cross country skiing with high schoolers or just mingling with whatever student needs an ear. Our officers' presence is one to teach kids that the police are not the bad guys, we are human too and can be a good friend and mentor.

The grant funding this program also paid for our officers to attend further training in August in New Orleans, Louisiana. They attended training with approximately 300 other School Resource Officers and School Administrators from all over the United States.

During 2001, our officers investigated hundreds of minor complaints with at least 18 involving activities rising to criminal levels. Of these 10 were closed through arrest including controlled substance violations, sex charges, bomb threats, violation of probation, larcenies, etc.

# D.A.R.E.

Our Certified D.A.R.E. Officer, Deputy Jerry Martin regularly gives presentations to numerous civic organizations concerning this important program as well as visiting all of the Essex County elementary schools and promoting the program for future implementation into their curriculum.

As a result, this program was taught to Kindergarten through 12<sup>th</sup> grades in 9 Essex County schools with 560 students in the 2001/2002 year receiving the program

This program is funded through donated materials and monies for supplies. Each student receives workbooks, a t-shirt at graduation and at various times in the curriculum, incentives such as pencils, certificates, stickers, etc. These items are all funded through public support.

## **NARCOTICS ENFORCEMENT**

The Essex County Sheriff's Department Narcotics Unit was involved in many cases during the year 2001.

As a member of a Federal, State, County and Local Task Force, the Essex County Narcotics Officer has been involved in numerous arrest and seizures. During 2001, 33 new cases were investigated resulting in:

2 Search Warrants;

Over 1 kilo of crack cocaine;

120 packets of heroine;

Over 1,500 Ecstasy tablets;

64 Marijuana plants;

Combined Task Force sweep netted 60 in Canton area;

3 Algerians removed from bus in Plattsburgh immediately following September 11 terrorist attack.

Even though there were 33 new cases, there were also hundreds of new leads and pieces of information that are being evaluated and may lead to additional arrests, seizures and confiscations. When one source is arrested, the vacancy is soon filled and the "business" of drugs goes on.

## **NYSPIN**

Another tool that the Sheriff's Department utilizes in both the field of Corrections and Law Enforcement is the *New York State Police Information Network* computer terminal.

Everyone of the 482 inmates booked into the jail has a criminal history printout from this system included in their file. It is an automatic part of booking so that we are better informed on the type of individual that we are handling.

Also, we are the source for printouts for criminal histories for other departments authorized to access this information. During 2001, we also ran:

**346 Criminal History inquiries for Probation;**

**127 for the District Attorney, County Court, etc;**

**368 for County Clerk Pistol Permit background checks.**

## **DISPATCH**

Essex County Sheriff's Department is also responsible for dispatching of Emergency Equipment in the county. In 2001, this office received 1,744 citizen calls for emergency services. These calls can range from a single ambulance dispatch to a multiple fire department mutual aid. Time involved can be as little as 20 minutes for a very simple call to tying up 2 or 3 men for an entire shift for a major incident such as flooding, forest fire, major structure fire, etc.

**These 1,744 calls represent over two thirds of the squads in the county, but only 43.6% of the population as the larger towns are handled through their own or neighboring county emergency centers. When 9-1-1 becomes a reality, the numbers above will then increase accordingly as well as this agency becoming the point of contact for all police calls within the county.**

## CIVIL

By law, the Sheriff is the designated official in the County to affect the service of civil process, execute court mandated orders such as evictions, seize property ranging from vehicles to bank accounts, cash register contents, land and property, etc and conduct sales to raise funds necessary to satisfy court ordered judgments.

Any civil, Family Court, Grand Jury or trial action requires notification of the people involved. This notification comes in the form of a civil summons, subpoena, summons and petition, etc. These are the documents that the Sheriff is charged with serving. As you can imagine, people in serious legal difficulties are not easily found. We find that the services contain the address at the time of the incident and the people have moved numerous times since. This requires a large amount of time and resources to locate and serve the documents or take the mandated action necessary to satisfy the court order. Unfortunately, when the economy slumps, our business soars as credit and monies are not available and people are forced to default on their obligations.

## **COURT SECURITY**

The Sheriff's Department is also charged with the security of the County, Supreme, Family and Surrogate's Courts held in and for the County of Essex. Currently we have 2 full time officers in addition to part-time attendants and supplement their services with overtime as the court schedule demands.

As a part of our contract with the Unified Court System, we are reimbursed for services rendered. This **reimbursement for 2001 totaled \$176,788.20.**

2001 saw Essex County Court System handle 469 Supreme and County Court Cases with 7 jury trials as well as thousands of Family Court and Support Enforcement cases and appearances.

The Essex County Court Building houses the Supreme, County, Surrogates' and Family Courtrooms and offices, the Essex County Clerk's Office, Department of Motor Vehicles, District Attorney's Office and Essex County Law Library. In 2001, excluding employees and Officers of the Courts, a total of over 117,350 visitors passed through the security desk in the lobby of the building.
