

Boarding out

Cost for overflow inmates for 2002 - \$438,412.00

(Daily average for 2002 - 16 inmates)

The Essex County Sheriff's Department was forced to Board Out overflow inmates in excess of our jail capacity during 2002. For the calendar year of 2002, this amounted to 6,475 "bed days", up from 6,145 in 2001.

- This is a double murder (1 murder in Sullivan County, 1 murder in Essex County) suspect currently being in Sullivan County on a court order for their felony court proceedings.

Female inmates

Female inmates were a large part of the "housing out". 2002 saw **49 female inmates for a total of 1,285 days.**

Due to a behavioral issue, we had one minor female inmate that we were unable to find long-term housing. This resulted in having to move her among a number of facilities requiring a high number of transport miles and time for officers.

New Programs

St Joseph's Substance Abuse Program has been active in the facility with the services of Nancy Dawson. During 2002, she performed:

77 Evaluations;

245 Individual sessions;

132 Group sessions;

91 Screenings;

Sessions with the Inmate's family;

39 referrals were made to post release treatment programs with 18 of these following through with the appointments.

Intermittent Inmates

"Part time" inmates are a continual problem for jails with limited space. In order to allow a defendant to maintain gainful employment or remain in school or college but still satisfy a court ordered sentence, Judges hand down a sentence ordering the defendant to serve specific days in jail and be out for the remainder of the week. While the days to be served can be anything, the most common is reporting to jail on Friday night and serving until Sunday night. These sentences can run up to one year in duration. ***Last year, we had an average of 2 intermittent inmates every weekend with a high of 9.*** This means boarding out enough inmates on Friday to make room for these incoming inmates and then returning "our" inmates on Sunday - entailing transportation and overtime costs for both trips.

An average of 2 intermittent inmates per day translates to 730 bed days. These bed days, if all resulted in boarding out inmates translate to a minimum housing cost of almost \$55,000.

Medical care

As we are legally obligated to "take and safely keep all inmates legally committed", we occasionally have inmates being hospitalized while committed to the Sheriff's custody. This requires 24 hour guarding of the inmate requiring overtime to accomplish.

2002 had 1 Inmate hospitalized for 4 days.

This is a significant reduction from past years and I believe this can be attributed to the full time nurse currently employed by the facility. This allows for a continuity of care and better screening for potentially dangerous medical conditions.

Mental Health Services

A large part of jail treatment involves Mental Health Services. Essex County Mental Health, via Richard Jack as the primary Jail Contact has evaluated and counseled a high percentage of our jail inmates. Worry over legal issues, family separation, self destructive tendencies and self worth are all very serious concerns to those incarcerated. These concerns can be partially alleviated through an attentive ear and sometimes by just talking things out.

During 2002, Essex County Mental Health made 243 contact sessions with 140 inmates in the county jail.

Inmate Transports

Court Transports

In 2002, Court, Board and medical transports resulted in the following:

(1123 1/2 hrs regular paid time and 954 Overtime hours)

Justice Courts - 149 transports moved 188 inmates;
(359 hrs regular paid time and 517 1/2 overtime hours)

(233 hrs regular paid time and 168 overtime hours)

Juvenile Transports - (under 16 years of age)
14 transports moved 14 juveniles
(63 hrs regular paid time and 87 overtime hours)

Grand totals:

469 transports moved 869 inmates over 65,843 miles requiring 1778 1/2 regular time hours and 1726 1/2 overtime hours of staff time.

Juvenile Transports

Juvenile transports (under 16 years of age) are always a budgetary drain.

2002: 14 Transports for 14 youths covering 4,161 Miles;
63 regular staff hours;
87 overtime staff hours.

Most juvenile transports come on a moments notice and can result in transportation to a local non-secure detention home or to one of the secure facilities anywhere in the state.

"State Inmates"

State overcrowding is also reflected in our figures as we housed **10 Parole Violators for a period of 577 days** waiting for the return process to be completed and the offender to be returned to the State System.

This is a 47.6% increase in housing over last year.

When the jail is full, these extra state inmates cause us to board out. If we had to board out for the entire 577 days at a cost of \$70/day (most county costs exceed this figure) then **577 bed days boarded out would cost us \$40,390 and in return, the maximum state reimbursement allows \$19,618 for housing these inmates. This is a net loss to Essex County of \$20,772.**

State Ready

We also have a problem with the holding of inmates between sentencing to a State facility and the actual transportation to prison. The Department of Corrections is under Court order to take these inmates within 10 days, but due to overcrowding, this deadline is not regularly met. When this happens, we receive \$34.00 per day for housing in excess of the statutory 10-day period. **Last year, we held 10 over the statutory 10-day limit, up from 4 from last year.**

In 2002, we held **12 State Ready inmates** for a total of **239 days**. In the same scenario as Parole Violators, these beds would cost us \$16,730 in board out costs while maximum reimbursement was \$8,126 leaving a **deficit of \$8,604.**

Convicted Felons Sentenced to the County Jail

Another area of "State" inmates in the county jail is an inmate convicted of and sentenced for a felony, but sentenced to a term of 1 year or less. This results in the inmates doing their time in the county jail without state reimbursement. In 2002, we had **54 of these inmates for a total of 3,716 days** of housing after their sentences. These days, **if** boarded out would cost **\$260,120**. This is a total loss to the county as the previous \$17.00 per day reimbursement was eliminated last year. Should this reimbursement have still been in place, the total claimed would be **\$63,172**.

Jail Incidents & Discipline

Operating any detention facility is a risky job to the employees. Essex County Jail expects the inmates committed to the jail to live by certain rules and regulations for the safety, security and good order of the facility.

Last year, we had 28 offenses serious enough for formal written Disciplinary charges as well as innumerable minor offenses handled by the officers.

Of these 22 were offenses involving contraband, fighting, unruly behavior, etc.

10 offenses involved fighting with one also involving an injury to an officer.

VINE

(Victim Identification and Notification Everyday)

This program allows anyone to call a toll free number and determine if an offender is in a county jail, NYC lockup or state prison in New York State. If so, the caller can request notification upon the offender's release. Within 15 minutes of the offender's release, the computer will place a call notifying the interested party of the release. This is a completely anonymous computerized service and is free to the user.

While this system is designed for the victim, anyone can utilize the system - District Attorneys, police, press, defense attorneys, courts, virtually anyone with the name of an offender and the interest in knowing the release date.

Through this grant, we are able to provide posters, pamphlets, instructional videotapes, etc to all police agencies in Essex County as well as agencies such as End Domestic Violence, Probation, Mental Health, Hospitals, all courts, etc.

This system made 46 release notification calls in 2002.

DNA Indexing

New York State has implemented a system whereby certain felony offenders are required to provide a sample for DNA indexing. This is to build a database of convicted offenders for future reference where DNA trace evidence is left at a crime scene.

Since its inception, New York State has received 106,453 collections of DNA and has had 806 "hits" whereby an offender was identified as being present at a crime scene through a match of DNA. In 45 of these cases, the DNA specimen was collected from an inmate in a county jail. In addition, New York State's DNA collections have provided "hits" on DNA from 75 cases nationwide. Currently, New York has 7,447 crime scenes catalogued where DNA evidence has been collected but no matches have been made to date.

Through this program in 2002, Essex County Jail has identified 5 target convicted offenders in our jail and have harvested and forwarded the necessary biological evidence to the state for inclusion in the register. This brings Essex County's contribution to the register to 30 since the inception of the program.

One notable New York State case during 2002 involved the solving of a 9-year-old rape case through a match with a collected DNA sample from this program. Also resolved was an Allegany County murder case. In this case, police had identified a suspect but a DNA "hit" confirmed their suspicions and allowed the murder case to be solved.

Facility Nurse

In order to better provide medical care for our inmates, to assist Dr. Herbert Savel and to comply with state requirements, Mary Murphy oversees the medical delivery inside the facility.

Ms. Murphy continues to make a significant impact on services in the jail. Her duties include, but are not limited to:

- testing all inmates for TB;
- medical screening of all incoming inmates;
- supervision of inmate medications;
- oversight of regular "sick call";
- supervision of special medical needs inmates such as diabetics, cardiac patients, post surgical, etc.;
- training of staff in medical areas;
- annual testing of staff for TB;
- inoculation of staff for flu, hepatitis, etc prevention, and;
- work closely with Dr. Savel to insure adequate medical services are provided to the inmate population, thereby reducing liability of the facility.

We are seeing a significant improvement in medical care to inmates primarily in screening of new inmates for medical, mental health and substance abuse cases as well as being referred to appropriate treatment programs to help defer recidivism in these problem areas.

Also with a trained professional working full time in the medical office we are able to better keep a handle on our medication budget through medication management and use of over the counter remedies in place of sometimes very expensive prescriptions.

SEX OFFENDER REGISTRY

The law, which went into effect January 21, 1996 provides for individuals committing a sex crime and convicted after the date of the law's enactment to fall under certain reporting requirements. Sex offenders are classified in 3 levels: Level 1 offenders are the minimum level followed by Level 2 offenders and the highest risk category being Level 3.

Level 1 and 2 offenders are subject to an annual verification of their living address with the State as well as having their information on file with the police. Level 3 offenders are required to report to the appropriate police agency every 90 days and personally verify their address and any other information the police feel pertinent about their employment, living situation.

The New York State Sex Offender Registry makes notifications to the Police Entity having jurisdiction over individuals in the community. This means that in the case of someone living in a town or village with a police department, the PD would get notification.

All other notifications come to the County Sheriff for appropriate filing and action.

The appropriate police agency receiving the offender information is then responsible for making public notification to "vulnerable public entities". The Essex County Sheriff's Department has determined that in this age of easy transportation, any and all agencies such as schools - both public and private, nursing homes, day care providers, hospitals, Family Counseling agencies, Summer Camps, Senior help agencies will be notified. In addition, we share our offender information with neighboring County Sheriff Departments as well as all police agencies within the county. This translates to a mailing list of almost 50 agencies.

At the present time, the Essex County Sheriff's Department has 3, Level 3 offenders reporting to this office every 90 days. In addition, we have made notification on 8 Level 2 & 3 offenders to our mailing list of vulnerable entities. Unfortunately, we can only make notifications on those convicted after the effective date and then only if the crime of conviction is one as covered by the existing law.

This office also routinely receives reports of offenders who have failed to register as required by state law. When we receive a report, we assign an officer to investigate and most failures result in a Misdemeanor arrest for a minimum of Failure To Register and can also include the misdemeanor of Failure to Change Address.

PATROL

During 2002, this department received 67 **Arrest Warrants** for execution. These warrants were for individuals anywhere in the state or country. As of January 2003, 49 of these warrants were closed through arrests, vacated by the courts or otherwise withdrawn. The 18 outstanding warrants are still in process of locating the defendant/respondents or when located have been filed with other agencies awaiting the defendant to be available for arrest. Some are out of the state or country, others have moved and the whereabouts are unknown, still others are located in other counties in New York State and we are at the mercy of their Warrant Squads to make the arrest and turn them over to us.

Our patrols accomplished 104 **arrests** during 2002. These were Family Court Warrants as well as criminal offenses ranging from felonies down to violations. Our patrols also issued **866 Uniform Traffic Tickets.**

These patrols also investigated numerous motor vehicle accidents. Of these, 21 were serious enough, either in physical injury or property damage for formal written investigations.

As a police agency, this department also logs incidents. An incident is a term given to any type of complaint, response or action. We logged 160 incident for last year. Our incidents ranged from citizen assists, to stranded motorists, lockouts from cars and houses, prowler complaints, missing children, suspicious vehicles, loud parties, animal complaints, alarms, etc. Also, in these incidents are assists to other agencies such as Police, Ambulance squads and assisting in the search for escapees such as the one from New York State Department of Corrections Shock Camp Moriah and Federal Correctional Institute Ray Brook in past years. The remainders of the incidents range from domestic disputes and family offenses to alcohol complaints, DWI, traffic complaints, Burglary, dangerous drugs, vehicular accidents, etc.

Also included in our duties are security for special events and visits by dignitaries. Some noteworthy events during 2002 were:

- Buckle Up New York Seat Belt enforcement;
- ESPN Great Outdoor Games, Lake Placid;
- ISUZU Ironman Triathlon, Lake Placid;
- Adirondack Marathon, Schroon Lake;

Grants received and utilized by this department:

In the wake of September 11th Terrorist Attacks and the increased risk of biological threats, our officers have been trained in protocols to be used in handling suspect mail. During the latter part of 2002 our officers investigated suspected pieces of mail. All proved negative to an active threat, but had they been a risk, they were handled professionally and safely reducing risk of spreading contamination.

NARCOTICS ENFORCEMENT

The year 2002 saw the Essex County Sheriff's Department Narcotics Officers working closely with the Adirondack Drug Task Force. The Task Force is made up of members of the New York State Police, U.S. Drug Enforcement Administration, FBI, Clinton County Sheriff's Department, Plattsburgh Police Department, ATF, Ticonderoga Police Department as well as this Department and various other agencies of the State and Federal Governments. While working with this group in 2000, "Operation Clear Coat" was formulated. After two years of work, that case, culminated in the arrest of 29 individuals from Clinton and Essex Counties in June of 2002. Our work with that group continues.

During the past year, surveillance and assistance from the public lead to the harvest of just under 1,200 marihuana plants. These plants had a street value of many hundreds of thousands of dollars. With more investigation and the public's help, we hope we can continue to eradicate as many plants as possible before they are distributed on the streets.

Some interesting cases from 2002:

- While working with the Task Force, a subject from out of state was arrested just outside of Bloomingdale with approximately \$287,000.00 in U.S. currency. Further investigation into this case led to the seizure of over 200 pounds of marihuana.
- We were asked by an employer in Lewis, to set up surveillance of a night shift employee as he was suspected of using or selling marihuana. Upon doing so, he was arrested for Possession of Marihuana as well as Possession of Child Pornography. Additionally, a search warrant was obtained for his residence, which turned up more pornography. The subject pled guilty to the charges and was sentenced to jail.

- While on patrol, a Deputy Sheriff noticed a car being operated without a license plate light. After further observing the car, he saw that it was being operated in an erratic manner. Upon being stopped, he arrested all 5 occupants on charges of marihuana, crack cocaine and heroin possession. The subjects possessed 95 packets of heroin and were enroute to Plattsburgh.

During the past year, 45 new cases were opened. Eight cases were closed by arrest and another eight were closed by Court Ordered Destruction without a defendant. Many cases are being actively pursued from the past year as well as 2001 cases. Our share of seized assets for the past year total approximately \$37,000.00

NYSPIN

Another tool that the Sheriff's Department utilizes in both the field of Corrections and Law Enforcement is the New York State *Police Information Network* computer terminal.

Every one of the 520 inmates booked into the jail has a criminal history printout from this system included in their file.

It is an automatic part of booking so that we are better informed on the type of individual that we are handling.

Also, we are the source for printouts for criminal histories for other departments authorized to access this information. During 2002, we also ran:

211 Criminal History inquiries for Probation;
29 for the District Attorney, County Court, etc;
394 for County Clerk Pistol Permit background checks.

DISPATCH

Essex County Sheriff's Department is also responsible for dispatching of Emergency Equipment in the county. In 2002, this office received 1,726 citizen calls for emergency services. These calls can range from a single ambulance dispatch to a multiple fire department mutual aid. Time involved can be as little as 20 minutes for a very simple call to tying up 2 or 3 men for an entire shift for a major incident such as flooding, forest fire, major structure fire, etc.

These 1,726 calls represent about two thirds of the squads in the county (29 of 42) as the larger towns are handled through their own or neighboring county emergency centers. When 9-1-1 becomes a reality, the numbers above will then increase accordingly as well as this agency becoming the point of contact for all police calls within the county.

CIVIL

By law, the Sheriff is the designated official in the County to affect the service of civil process, execute court mandated orders such as evictions, seize property ranging from vehicles to bank accounts, cash register contents, land and property, etc and conduct sales to raise funds necessary to satisfy court ordered judgments.

Any civil, Family Court, Grand Jury or trial action requires notification of the people involved. This notification comes in the form of a civil summons, subpoena, summons and petition, etc. These are the documents that the Sheriff is charged with serving. As you can imagine, people in serious legal difficulties are not easily found. We find that the services contain the address at the time of the incident and the people have moved numerous times since. This requires a large amount of time and resources to locate and serve the documents or take the mandated action necessary to satisfy the court order. Unfortunately, when the economy slumps, our business soars as credit and monies are not available and people are forced to default on their obligations.

COURT SECURITY

The Sheriff's Department was also charged with the security of the County Court Building and the courts therein. On November 21, 2002, New York State took over control of the security of the Essex County Court building. The 3 officers we had stationed in the building opted to stay with the court and become State Employees. The 6 part-time attendants have not yet been grandfathered into state employment.

As a part of our contract with the Unified Court System, we were reimbursed for services rendered. This reimbursement for 2002 totaled \$203,016.60.

2002 saw Essex County Court System handle **495** Supreme and County Court Cases with **11 jury trials** as well as thousands of Family Court and Support Enforcement cases and appearances.

In 2002, excluding employees and Officers of the Courts, a total of over **81,120** visitors passed through the security desk in the lobby of the building.

SCHOOL RESOURCE OFFICER PROGRAM

The School Resource Officer Program is vital to keeping close ties and good working relationships with our youth in schools today. Currently we have 4 school resource officers (Deputies Shawn Lydamore, David Reynolds, Thomas Murphy and Albert Leon) and of these 2 are cross-trained as D.A.R.E. officers and also Certified Car Seat Technicians as well.

School Resource Officers (SRO's) work directly in the schools doing a limitless amount of duties such as teaching vital subjects like the Eddie Eagle gun safety program, Halloween safety, bullying, bicycle safety, etc. These officers also devote a tremendous amount of time to their schools in extracurricular programs such as walk-a-thons, field trips like hikes and educational trips, sporting events, guest lecturer for boy scouts, ELKS or other community organizations, a resource for students, teachers and parents on issues of law enforcement and corrections, etc. Our officers are also members of the school's Safety Committees and act as a liaison to the department on issues of physical safety.

These officers also act as a "Town Cop" for the school, handling criminal complaints, making arrests, following school busses for illegal passing of stopped busses, handling disorderly students, etc. While arrests are not an everyday event, they are made for such crimes as Criminal Mischief, Larceny etc.

One of our officers even creatively "staged" traffic stops of the Driver's Education car and educated the children in the amenities of a traffic stop. This teaches the driver not to be scared and just what to expect during a stop - what documents to produce, the questions typical of a stop, etc.

A typical day starts with a stop in the Main Office to announce their presence and see if any pressing issues need their immediate attention. Thereafter, these officers teach, mentor, have lunch with the children, participate in reading programs, be a neutral listener for students, etc. As a result of these programs,

the perception of Police has changed dramatically in these communities and is now seen as someone there to help, not an adversary out to catch you doing something wrong.

Some very important activities include education dealing with alcohol and driving. We have a set of "Fatal Vision" goggles that simulate an intoxicated driver's vision. Students have the opportunity to use these goggles and walk or do normal tasks, which quickly brings home the physical changes that alcohol makes on the body.

The Car Seat Safety Technicians operate via a grant and perform checks of child safety seats for any interested parties. Typically, we operate in conjunction with a number of other jurisdictions on pre-scheduled days. Our officers instruct the owners on the proper method of securing the child seats in the vehicle as well as perform a safety check on the equipment. If the seat is defective or unsafe, the grant has provided for replacement seats and the unit is removed and replaced on the spot free of charge to the parents.
