In 2019, there were 135 police officers killed in the line of duty throughout the United States. This is down from 167 officers killed in the line of duty in 2018. The highest cause of death was gunfire followed by an automobile crash. There were no line of duty deaths reported in the State of Massachusetts during 2019.


Introduction

The Fall River Police Department has the enviable distinction of being one of the oldest police departments in the country. Our long and proud tradition dates back to 1854, when the first constable hit the streets to begin his tour of duty. For over 150 years, the people of Fall River have entrusted not only the authority, but also their welfare to the police. We have always endeavored not to abuse that authority and to hold their welfare sacred.

In 2017 the Fall River Police Department hired a Crime & Data Analyst who provides accurate and more detailed data. The numbers in this report for 2018 and 2019 may look drastically different than past years. That is the result of the analyst. Moving forward, the numbers produced will be an accurate depiction of what they are representing.

Contained in this document is the 2019 year end crime report for the Fall River Police Department.

Accreditation



In August of 2005, the Fall River Police Department started the process towards becoming a certified and accredited law enforcement agency. The FRPD had its eyes on certification and accreditation by the Massachusetts Police Accreditation Commission (MPAC) and national accreditation by the Commission of Accreditation for Law Enforcement Agencies (CALEA). The process of becoming an accredited agency is to meet and maintain standards that have been established by and for the profession.

The first step that the FRPD took was to become certified by the MPAC. The department invited independent assessors from the MPAC to review the department policies and procedures. Based on the MPAC's findings and the department as a whole, the FRPD was awarded certification from the MPAC in December of 2006. At that time the FRPD was the largest department to be awarded certification status.

After receiving certification status, the FRPD strived to receive accreditation status. The department had to comply with over 400 standards to be given the honor of being accredited which was given to the FRPD in June of 2007. The accreditation status is given to a department for a period of three years. Every three years the department has reapplied for accreditation status and been given the honor each time.

In November of 2009 the FRPD was given the highest accreditation, national accreditation. CALEA gives department's accreditation status for a period of three years and after that the department has to reapply. There are approximately 18,000 police departments in the United States and of those, less than 600 are accredited by CALEA. The FRPD is the largest municipal police agency in New England to obtain accreditation from CALEA.

2019 was a big year for the FRPD and its accreditation status. The FRPD was re-accredited by both the MPAC and CALEA. The department will be up for re-accreditation again by both CALEA and MPAC in 2022.

Overview of 2019 Part A Crimes


Part A crimes break into two categories; violent and property. Violent part A crimes consist of murder, sexual assault, robbery and aggravated assault. Property part A crimes are burglary, larceny, motor vehicle theft and arson. The following is a breakdown of Fall River's part A crimes committed in 2019.

In 2019, there were 2,462 part A crimes committed in Fall River which is a decrease from 2,558 part A crimes committed during 2018. Violent crimes showed a decrease of 15.15% whereas property crimes showed an increase of 2.13%.





Sexual Assault

During 2019, the Fall River Police Department responded to 137 sexual assault calls which is a decrease from 2018 by 22.16%. The following is a chart depicting the increase of sexual assault calls over the last few years.




From 2015, sexual assault calls have gone up 226.19%.


Sexual assault reporting is on the rise not only in Fall River but across the nation. There are many contributing factors as awareness has risen; social media and even the recent Hollywood investigations have all shed light on the situation.

Robbery


During 2019, the Fall River Police Department investigated 112 robberies. This shows an 8.94% decrease from the prior year. Of the 112 robberies, there were ninety where the robbery committed was person to person whereas there were twenty-two robberies of a commercial business. Fifty-two robberies were committed while armed and sixty committed while unarmed. This shows a decrease of 24.64% in armed robberies and an increase of 13.21% in unarmed robberies.

It has been found by the FRPD that most of the personal robberies that happen in the city of Fall River occur during drug transactions.





The following is a chart depicting the change of person and commercial robberies between 2015 and 2019.




Commercial robberies occur in banks, convenience stores, gas stations, restaurants, as well as other businesses. Of the twenty-two commercial robberies, there were twelve bank robberies.




2019 Robbery Map



Assault

In 2019, the Fall River Police Department responded to 571 incidents that resulted in at least one aggravated assault charge. This shows a 17.84% decrease from 2018. The following is a chart depicting the total number of aggravated assaults for 2015-2019.

The table on the previous page shows that 37.84% of all assaults include at least one aggravated assault charge. This is a ratio of 571 aggravated assaults to a total of 1,509 total assaults. The table on the previous page also shows that of the total assaults, 21.47% are both aggravated assaults as well as charges resulting from a domestic disturbance. Of the total aggravated assaults (571), 324 are both aggravated and domestic (56.74% of aggravated assaults).




Burglary

The burglary rate has showed a decrease over the last few years; however it has gone up from 2018 to 2019. During 2019, the Fall River Police Department investigated 575 burglaries which is a 31.88% increase from 2018.



















Firearm Arrests & Seizures





Drug Arrests

This year the FRPD arrested 641 individuals on a drug charge which is a drastic increase of 28.97% from 2018. This is attributed to an increase in detectives assigned to the Vice & Intelligence Unit.




The following is a chart showing the drug arrests over the last five years.

There were a total of 641 drug related arrests. Of the 641 arrests, 339 individuals were arrested by the VICE & Intelligence Unit, 148 by the Uniform Division, eighty-eight by the Special Operations Division, and four by the Major Crimes Division.

Prostitution Arrests

This year the FRPD arrested seventy-one individuals on a prostitution charge which is a decrease of 26.04% from 2018 (ninety-six arrests in 2018).

There were a total of seventy-one prostitution arrests. Of the seventy-one arrests, forty-nine individuals were arrested by the VICE & Intelligence Unit, fifteen by the Uniform Division, and seven by the Special Operations Division.



Calls can also come in through the routine line, 9-1-1 and walk-ins.





The FRPD saw a decrease in calls for service throughout the year by 7.72%.





Mental Health


The Communications Division received a total of 1,252 calls for service due to a citizen having a mental health crisis in 2019. This is a slight decrease of 2.57% from 2018. From 2015, the rate of mental health calls has gone up drastically at 21.32%. The police department receives the most calls regarding mental health between 1500hrs – 1900hrs. The following is a chart depicting mental health calls for service received by the communication division in 2019.







The Communications Division runs a similar schedule as sworn officers, day watch, first watch and last watch. The difference between the Communications Division and the sworn officers is the hours. Day watch runs from 0700 hours to 1459 hours, first watch from 1500 hours to 2259 hours and the last watch from 2300 hours to 0659 hours.

The Fire Department receives calls and is dispatched through the Emergency Dispatchers within the Communications Division employed at the Fall River Police Department.

The FRPD Communications Division received 7,283 calls for service where a fire response was needed. This is a decrease from 2018 by 8.38% and an increase in the last five years by 9.90%. 
Communications Division- EMS Calls




The FRFD EMS Division operates multiple medical rescue units. Twenty-four hours a day, seven days a week, there are five rescue units on duty in Fall River (Rescue 2, 3, 4, 5, 6). There is also "Squad 11" which is the EMS Lieutenant and firefighter for the shift to act as a quick response vehicle. In August, the EMS Division gained another medical rescue, "Rescue 9". "Rescue 9" runs Monday through Friday from 0800 hours – 1800 hours. The EMS Division gained another rescue in December, "Rescue 10". "Rescue 10" runs Monday – Friday 1200 hours – 2200 hours). Due to the high number of medical rescue calls to Prima Care, since April there has been a paramedic stationed at the location. The following is a breakdown of EMS runs by medical rescue.

Domestic Violence

The number of domestic violence calls for service increased yearly peaking in 2018 with 3,691 domestic violence calls. However, in 2019 there were a total of 3,329 domestic violence calls for service, which represents a 9.1% decrease from the previous year.



The Fall River Police Department Communications Division uses two codes for domestic violence related calls. One code is a 46VL which is a general domestic violence call. The other code is a 50GD which represents a domestic violence call in which there is a weapon involved. Calls are coded based on the initial information given by the caller(s) and may not reflect what officers encounter once on scene. Therefore, the number of calls for domestic violence may not represent the total number of domestic violence reports that are pulled each year. The following is a chart depicting the different rates of both 46VL and 50GD codes used over the last five years.



Overdoses

The overdose epidemic has been hitting the United States and Fall River is not exempt from that.

Fall River has seen an increase in overdoses over the last few years.

In 2016, there were a total of 882 overdoses including fifty-six fatal overdoses. In 2017, there were 914 overdoses with sixty-one fatal overdoses. Between 2016 and 2017 there was a 3.63% increase in overdoses. 2018 showed a steeper increase of 12.04% which represents 1024 overdoses including sixty-two fatal overdoses. In 2019, there were a total of 907 overdoses including seventy-two fatal overdoses. The 2019 numbers represent an 11.43% decrease from 2018 for total overdoses and a 16.13% increase in overdose deaths.



Numerous departments and cities around the country are developing programs to help those who need assistance in dropping the habit. In Fall River, "Project Reconnect" was developed. Project Reconnect operates with assistance from the FRPD, FREMS, FR City Hall, Bristol County D.A.'s Office, SSTAR, Seven Hills Foundation, Recover Fall River, Treatment Development Corporation, BOLD Coalition, St. Anne's Hospital and Charlton Memorial Hospital.

Project Reconnect's mission statement is "for citizens and community organizations to work together to provide continuous care for an individual suffering from substance abuse disorder who's recently overdosed and to connect them and their loved ones to needed services in or around Fall River who will provide assistance and support for them to begin and maintain recovery. Our Recovery Connection Team provides hope and resources without judgment or bias to see to it that no addict be left behind."


The volunteers involved in Project Reconnect reach out to individuals after an overdose and try to offer assistance to them and their families.



Motor Vehicle Accidents

In 2019, the FRPD responded to 4,829 motor vehicle accidents which is up from 4,141 motor vehicle accidents in 2018. This represents an increase of 16.61%. The number of citations issued due to motor vehicle accidents has also increased as did the number of accidents with injuries.



The following is a breakdown of the 2018 and 2019 motor vehicle accident data by month.



As illustrated above, the top three months for accidents in the city of Fall River in 2019 are July, August and April. This is a slight change from 2018 where the top three months would be August, January and July.

The following chart depicts the number of motor vehicle accidents broken down by day of the week. In 2019, Tuesdays and Fridays had the highest number of motor vehicle accidents.

The number of citations issued due to a motor vehicle accident increased by 3.66% from 2018 to 2019. The number of citations issued went up from 2015 to 2016 and then again in 2017 to 2018. There was a decrease in citations from 2016 to 2017. There is an increase of citations issued due to a motor vehicle accident of 8.26% from 2015 to 2019.

The number of accidents that result in injuries has shown a similar trend as the citations. The number of accidents resulting in injuries has increased 1.79% since 2018 and has increased 15.29% since 2015. The number of citations had a drop from 2016 to 2017 however; the total number of accidents resulting in injuries did not drop at any point between 2015 and 2019.
