


## Introduction

The Fall River Police Department has the enviable distinction of being one of the oldest police departments in the country. Our long and proud tradition dates back to 1854, when the first constable hit the streets to begin his tour of duty. For over 150 years, the people of Fall River have entrusted us to police the community. Our officers believe in integrity, professionalism, and selfless service.

Contained in this document is the 2021 mid-year crime report for the Fall River Police Department.

## Organizational Chart



### Accreditation



In August of 2005, the Fall River Police Department started the process towards becoming a certified and accredited law enforcement agency. The FRPD had its eyes on certification and accreditation by the Massachusetts Police Accreditation Commission (MPAC) and national accreditation by the Commission of Accreditation for Law Enforcement Agencies (CALEA). The process of becoming an accredited agency is to meet and maintain standards that have been established by and for the profession.

The first step that the FRPD took was to become certified by the MPAC. The department invited independent assessors from the MPAC to review the department policies and procedures. Based on the MPAC's findings and the department as a whole, the FRPD was awarded certification from the MPAC in December of 2006. At that time the FRPD was the largest department to be awarded certification status.

After receiving certification status, the FRPD strived to receive accreditation status. The department had to comply with over 400 standards to be given the honor of being accredited which was given to the FRPD in June of 2007. The accreditation status is given to a department for a period of three years. Every three years the department has reapplied for accreditation status and been given the honor each time.

In November of 2009 the FRPD was given the highest accreditation, national accreditation. CALEA gives department's accreditation status for a period of three years and after that the department has to reapply. There are approximately 18,000 police departments in the United States and of those, less than 600 are accredited by CALEA. The FRPD is the largest municipal police agency in New England to obtain accreditation from CALEA.

The FRPD was re-accredited by both the MPAC and CALEA in 2019. The department will be up for re-accreditation again by both CALEA and MPAC in 2022.

### Overview of 2021 Part A Crimes


Part A crimes fall into two categories; violent and property. Violent part A crimes consist of murder, sexual assault, robbery and aggravated assault. Property part A crimes are burglary, larceny, motor vehicle theft and arson. The following is a breakdown of Fall River's part A crimes committed from January 1, 2021 through June 30, 2021 as compared to part A crimes committed the same time period in 2020.

So far in 2021, there were 1,054 part A crimes committed in Fall River which is a decrease from 1,083 part A crimes committed during the same time period in 2020. Violent crimes showed an increase of 26.32% whereas property crimes showed a decrease of 13.99%.

# Murder





## Sexual Assault





From 2017, sexual assault calls have gone down 37.23%.

## Robbery


So far in 2021, the Fall River Police Department has investigated 33 robberies. This shows a 29.79% decrease for the same time period in 2020. Of the 33 robberies, there were 25 where the robbery committed was person to person whereas there were eight robberies of a commercial business. Nineteen robberies were committed while armed and 14 committed while unarmed. This shows a decrease of 20.83% in armed robberies and a decrease of 39.13% in unarmed robberies.

It has been found by the FRPD that most of the person to person robberies that happen in the city of Fall River occur during drug transactions.





The following is a chart depicting the change of person and commercial robberies between 2018 and 2021 for January  $I^{st}$  through June 30th.



Commercial robberies occur in banks, convenience stores, gas stations, restaurants, as well as other businesses. Of the eight commercial robberies so far in 2021, there has been only one bank robbery.


# 2021 Robbery Map



### Assault

In the first six months of 2021, the Fall River Police Department has responded to 333 incidents that resulted in at least one aggravated assault charge. This shows a 41.70% increase from 2020. The table above shows that 47.17% of all assaults include at least one aggravated assault charge. This is a ratio of 333 aggravated assaults to a total of 706 total assaults. This table also shows that of the total assaults, 25.78% are both aggravated assaults as well as charges resulting from a domestic disturbance. Of the total aggravated assaults (333), 182 are both aggravated and domestic (54.65% of aggravated assaults).




# Burglary

During the first six months of 2021, the Fall River Police Department investigated 209 burglaries which is a 12.92% decrease from 2020.

From 2017 to 2021, burglaries have gone down 2.34%.









### Motor Vehicle Theft

From January 1, 2021 through June 30, 2021, the Fall River Police Department responded to 83 calls for service which resulted in motor vehicle theft charges. 2021 motor vehicle thefts are down from 2020 by 25.30%. 



### Arrests


Physical arrests made by the Fall River Police Department have gone down from 2017 to 2021 by a total of 46.92%. Summons arrests have also decreased from 2017 to 2021 by 27.49%. 


The following is a depiction of the physical and summons arrests made by the FRPD in 2021 by month. The chart shows that the busiest time for the department with arrestable offenses was in June.








### Firearm Arrests & Seizures







## **Gang Member Arrests**



This year the FRPD has arrested 209 individuals on a drug charge which is a decrease of 35.09% from 2020.





The above table shows 87 total calls for service, but lists 88 categorized calls. This is due to the double homicide also having a non-fatal victim. That call is represented as one fatal call and one non-fatal call.

2021 showed an increase of 7.41% for total shots fired calls from 2020. Fatal shots fired calls are down 33.33% from 2020. Non-fatal shots fired calls have increased 250.00% from 2020.




### Calls for Service

A call for service can be received by the Fall River Police Department in many ways. Calls can be generated from what we refer to as "on view", which means that while the officer is on their patrol they are flagged down by a citizen requesting assistance. Calls can also come in through the routine line, 9-1-1 and walk-ins.

The numbers depicted throughout this section include all calls received by the FRPD Communications Division. This includes all police, fire, and EMS calls for service.





The FRPD saw an increase in calls for service throughout the first six months of 2021 by 2.86%.





### Mental Health


The Communications Division has received a total of 528 calls for service due to a citizen having a mental health crisis from January 1<sup>st</sup> through June 30<sup>th</sup> of 2021. This is a decrease of 6.55% from 2020. Since 2017, the rate of mental health calls has gone down 9.43%. ### Communications Division-Fire Calls


The Communications Division runs a similar schedule as sworn officers, day watch, first watch and last watch. The difference between the Communications Division and the sworn officers is the hours. Day watch runs from 0700 hours to 1459 hours, first watch from 1500 hours to 2259 hours and the last watch from 2300 hours to 0659 hours

The Fire Department receives calls and is dispatched through the Emergency Dispatchers within the Communications Division employed at the Fall River Police Department.

In the first six months of 2021, the FRPD Communications Division received 3,100 calls for service where a fire response was requested. This is a decrease from 2020 by 0.77% and also a decrease since 2017 of 15.72%. The following is a chart depicting the fire calls received by the FRPD Communications Division for the last five years:




### Communications Division- EMS Calls

The FRPD Communications Division received and dispatched 9,961 calls for service where an EMS response was requested. This is an increase from 2020 by 8.39%. 2021 calls for service that requested an EMS response is up 7.23% since 2017. 

### **Domestic Violence**

The number of domestic violence calls for service has been decreasing each year since 2018. In 2021, there were a total of 1,543 domestic violence calls for service, which represents a 4.93% decrease from the previous year.



The Fall River Police Department Communications Division uses two codes for domestic violence related calls. One code is a 46VL which is a general domestic violence call. The other code is a 50GD which represents a domestic violence call in which there is a weapon involved. Calls are coded based on the initial information given by the caller(s) and may not reflect what officers encounter once on scene. Therefore, the number of calls for domestic violence may not represent the total number of domestic violence reports that are pulled each year. The following is a chart depicting the different rates of both 46VL and 50GD codes used over the last five years.



### **Overdoses**

The overdose epidemic has been hitting the United States and Fall River is not exempt from that.

In January-June of 2017, there were a total of 401 overdoses including 27 fatal overdoses. In January-June of 2018, there were 486 overdoses with 31 fatal overdoses. Between January-June of 2017 and January-June of 2018 there was a 21.20% increase in overdoses. 2019 showed a slight decrease of 1.44% which represents 479 overdoses including 37 fatal overdoses. In 2020, there were a total of 301 overdoses in the first six months of the year to include 31 fatal overdoses. In 2021, there were a total of 317 overdoses and 26 overdose deaths. The 2021 numbers represent a 20.95% decrease from 2017 for total overdoses and a 3.70% decrease in overdose deaths.



Numerous departments and cities around the country are developing programs to help those who need assistance in dropping the habit. In Fall River, "Project Reconnect" was developed. Project Reconnect operates with assistance from the FRPD, FREMS, FR City Hall, Bristol County D.A.'s Office, SSTAR, Seven Hills Foundation, Recover Fall River, Treatment Development Corporation, BOLD Coalition, St. Anne's Hospital and Charlton Memorial Hospital.

Project Reconnect's mission statement is "for citizens and community organizations to work together to provide continuous care for an individual suffering from substance abuse disorder who's recently overdosed and to connect them and their loved ones to needed services in or around Fall River who will provide assistance and support for them to begin and maintain recovery. Our Recovery Connection Team provides hope and resources without judgment or bias to see to it that no addict be left behind."

The volunteers involved in Project Reconnect reach out to individuals after an overdose and try to offer assistance to them and their families.




### Motor Vehicle Accidents

In the first six months of 2021, the FRPD had responded to 1,969 motor vehicle accidents which are down from 1,704 motor vehicle accidents for the same time period in 2020. This represents an increase of 15.55%. The number of citations issued due to motor vehicle accidents has increased as did the number of accidents with injuries.

The following is a breakdown of the total number of motor vehicle accidents from January  $1^{st}$  through June  $30^{th}$  for 2017 to 2021.



The following is a breakdown of the 2020 and 2021 motor vehicle accident data by month.



As illustrated on the previous page, the top three months for accidents in the city of Fall River in 2021 are May, June and March. This is a change from 2020 where the top three months would be January, February and June.

The following chart depicts the number of motor vehicle accidents broken down by day of the week. In 2021, Tuesdays and Fridays had the highest number of motor vehicle accidents.

The number of citations issued due to a motor vehicle accident has increased by 9.18% from 2020 to 2021. The number of citations issued went down from 2017 to 2018 and again from 2019 to 2020. There was an increase in citations from 2018 to 2019. There is a decrease of citations issued due to a motor vehicle accident of 16.17% from 2017 to 2021.
