All residents on the street must be contacted and 80% must agree to closing the street. Neighbor contact will be verified by the completion of the Neighborhood Petition form.								
3.	 Movable barricades shall be used at the ends of the street to be closed and adequate lighting provided if the closure continues after dusk to alert motorists. 							
 Objects such as tents, tables and inflatable games that would hinder free access to emergency vehicles cannot be placed in the roadway. 								
5.	The Department of Public Works may provide barricades for street closure if they have an adequate supply and with plenty of advance notice.
