Access to necessary diagnostic services will be provided to offenders as requested by physicians or other approved health care providers. This policy is applicable to all facilities that house Georgia Department of Corrections (GDC) offenders to include private and county prisons.

- a. Clinical laboratory services for blood, urine, body fluids, and tissue analysis.
- b. Diagnostic radiology and radiologic interpretation services.
- c. Electrocardiographic, electromyographic, and electroencephalographic services and interpretation of examinations.
- 2. Facility laboratory services will include but not be limited to:
 - a. Finger-stick blood glucose test.
 - b. Multiple-test dipstick urinalysis.
 - c. Peak flow meter measurements.
 - d. Stool blood-testing material.
 - e. Microscope for wet mounts (at women's facilities).
- 3. Laboratory services will be provided in compliance with the Clinical Laboratory Improvement Amendment of 1988 (CLIA) Standards.
- 4. A reference laboratory will be used for other tests required to provide adequate services.
- 5. Laboratory and radiographic procedures require an order by a physician or other provider authorized by law to give orders.
- 6. A tracking system will be developed to monitor the completion of all tests ordered and will ensure the timely return of laboratory reports.
