CHAPTER 4 OPERATING MANUALS

4.0 PURPOSE

The purpose of this chapter is to provide information and guidelines about the department's maintenance of operating manuals.

4.1 POLICY

It is the policy of the Golden Police Department to maintain operating manuals that specifically affect the manner that a member performs their duties. These operating manuals may affect only specific divisions, or may affect the entire department. Every member should familiarize themselves with the operating manuals applicable to their duties.

4.2 MAINTENANCE OF OPERATING MANUALS

Each manual assigned to a division should be maintained in an up-to-date manner. Additions, deletions and changes to these manuals are the responsibility of the entities listed below. Division heads and/or supervisors should periodically inspect the manuals to ensure that updates have been added.

4.3 MANUALS / UPDATING

Operating manuals maintained and updated by the department are as follows:

- A. Field Training and Evaluation Program Manuals Maintained and updated by the division head overseeing a Field Training and Evaluation Program within their division.
- B. Critical Incident Response Field Guide Maintained and updated by the Patrol Division Head or designee.
- C. Recruitment Plan Maintained and updated by the Administration Division Head.
