BACKGROUND

In 2019 the Greenbelt Police Department handled 25,743 calls for service. Officers were assaulted during five incidents or .00019 % of the calls for service. In 2020 the Police Department handled 27,709 calls for service. Officers were assaulted during ten calls for service.

- There were ten incidents in 2020 that qualified under Law Enforcement Officer Killed and Assaulted (LEOKA) reporting requirements. Of these ten incidents, nine resulted in additional misdemeanor charges of 2nd degree assault and one incident resulted in four additional 1st degree assault felony charges.
- Nine of the ten incidents were as a result of a request for assistance (call for service). One was as a result of an officer initiated traffic stop that ended up being a stolen vehicle.
- There were no serious injuries to officers or suspects in any of these five incidents.
- There were no identifiable patterns that would warrant any policy changes or need for additional training in these areas. Prepared by:
