# 1. <u>PURPOSE</u>

The purpose of this policy is to establish personal appearance standards for the employees of the Hawai'i Police Department.

### 2. <u>PERSONS AFFECTED</u>

All department personnel.

# 3. <u>POLICY</u>

It shall be the policy of the Hawai'i Police Department that, as representatives of the department, personnel are expected to present a clean, neat, and professional appearance.

### 4. <u>DEFINITIONS</u>

- 4.1. **Fauxhawk** A hairstyle resembling a Mohawk in having a central ridge of upright hair but with the sides gathered or slicked upward or back instead of shaved.
- 4.2. <u>Mullets A hairstyle in which the hair is cut shorter at the front, top and sides, but is longer at the back.</u>
- 4.3. <u>Mohawk A hairstyle in which, in the most common variety, both sides of the head are shaven, leaving a strip of noticeably longer hair in the center.</u>

# 5. <u>RESPONSIBILITIES</u>

- 5.1. Commanding Officers shall be responsible for the monitoring of grooming standards for all persons under their command.
- 5.2. All personnel shall be individually responsible for compliance with applicable grooming standards.

# 6. <u>PROCEDURES</u>

- 6.1. Male Standards/Sworn Personnel
  - 6.1.1. Hair Styles

- a. Hair shall be neat, clean, trimmed, and present a wellgroomed <u>professional</u> appearance. The style is unacceptable whenever the hair is within one inch of the eyebrows, covers any portion of the ears, or extends below the top of the shirt collar. In no case shall the bulk or length of the hair interfere with the proper wear of any authorized headgear or interfere with the performance of assigned tasks or duties. <u>For</u> <u>examples of authorized male sworn hairstyles/haircuts see</u> <u>GO 511 Appendix A.</u>
- b. Wigs or hairpieces shall not be worn while on duty except for cosmetic reasons to cover natural baldness or physical disfiguration. If under these conditions a wig or hairpiece is worn, it shall conform to department standards for hair grooming.
- c. Sideburns shall not extend below the tip of the earlobe and shall be trimmed level. The forward and rear edge of the sideburns may be maintained following the natural hairline. Extreme styles such as mutton chops, thick or bushy sideburns, are not permitted.
- d. Extreme or eccentric hairstyles are not permitted. Hairstyles with a single, un-tapered patch of hair on the top of the head (not consistent with natural hair loss) are considered eccentric and are not authorized. Examples of prohibited hairstyles include but are not limited to mohawks, fauxhawks, mullets, ponytails, braided, or etched designs, shapes, or messages engraved into the hair or scalp (hair may be parted).
- e. <u>The length and bulk of the hair on top of the head may not be</u> <u>excessive and must present a neat and groomed appearance.</u> <u>The hair on top of the head may not display eccentric</u> <u>directional flow, twists, or spiking.</u>
- f. <u>Coloring, dyeing, tinting, or highlighting of hair must be in</u> good taste; unnatural hair colors are prohibited.
- 6.1.2. Facial Hair

- a. Officers shall report for duty cleanly shaven. A neatly trimmed mustache may be worn, provided that it does not extend below the axis of the upper and lower lip. Mustaches of the handlebar variety and those with waxed tips are not permitted. Facial hair under the lower lip is not permitted.
- b. Beards of any style are prohibited.
- 6.1.3. <u>Body Piercings Body piercing jewelry, including earrings, shall</u> <u>not be visible while on duty or while representing the department</u> <u>in any official capacity.</u>
- 6.1.4. Fingernails Fingernails shall not extend beyond the fingertips for safety reasons. Fingernails shall be well manicured and neat. Fingernail polish is prohibited while on duty or while representing the department in any official capacity.
- 6.2. Male Standards/Civilian Personnel
  - 6.2.1. Hair Styles
    - a. Hair shall be neat, clean, trimmed and present a well-groomed appearance.
    - b. In no case shall the bulk or length of the hair interfere with the performance of assigned tasks and duties.
    - c. Wigs or hairpieces shall not be worn while on duty except for cosmetic reasons to cover natural baldness or physical disfiguration. If under these conditions a wig or hairpiece is worn, it shall conform to department standards for hair grooming.
  - 6.2.2. Facial Hair Well-kept, trimmed, neat and clean beards and mustaches are permitted.
  - 6.2.3. Fingernails Fingernails shall not extend beyond the fingertips for safety reasons. Fingernails shall be well manicured and neat.
- 6.3. Female Standards/Sworn Personnel

- 6.3.1. Hair Styles Hair styles shall present a conservative and well-kept <u>professional</u> appearance. In no case shall the bulk or length of the hair interfere with the proper wear of any authorized headgear or interfere with the performance of assigned tasks or duties. For examples of authorized female sworn hairstyles/haircuts see GO 511 Appendix B.
- 6.3.2. Extreme or eccentric hairstyles are not permitted. Hairstyles with a single, un-tapered patch of hair on the top of the head (not consistent with natural hair loss) are considered eccentric and are not authorized. Examples of prohibited hairstyles include but are not limited to pigtails, ponytails, mohawks, fauxhawks, mullets, or etched designs, shapes, or messages engraved into the hair or scalp (hair may be parted).
- 6.3.3. <u>Coloring, dyeing, tinting, or highlighting of hair must be in good</u> taste; unnatural hair colors are prohibited.
- 6.3.4. Uniformed Officers Hair shall not be worn in a style beyond shoulder length. Hair which would extend beyond shoulder length shall be worn in a neat fashion and securely fastened. Hair holding ornaments (barrettes, pins, clips), if used, must be transparent or similar in color to the hair.
- 6.3.5. Non-Uniformed Officers Hair shall not extend beyond the bottom of the shoulder blade. If the hair extends beyond the shoulder blade, it must be worn up in a neat fashion and securely fastened.
- 6.3.6. Cosmetics Face and eye cosmetics shall be neatly and thinly applied and shall harmonize with the wearer's hair color and the color of the police uniform. False eyelashes are prohibited and perfumes shall be used with propriety.
- 6.3.7. <u>Body Piercings Body piercing jewelry, including earrings, shall</u> not be visible while on duty or while representing the department in any official capacity.
- 6.3.8. Fingernails
  - a. Uniformed Officers Fingernails shall not extend beyond the fingertips for safety reasons. Fingernails shall be well

manicured and neat. Fingernail polish and false fingernails are prohibited when in uniform. An exception is the wearing of a clear fingernail polish.

- b. Non-uniformed Officers Fingernail polishes and false fingernails are acceptable for on-duty plainclothes assignments. The length of fingernails should not interfere with the performance of assigned tasks or duties. Fingernails shall be well manicured and neat.
- 6.4. Female Standards/Civilian Personnel
  - 6.4.1. Hair Styles Hair styles shall present a conservative and well-kept appearance. In no case shall the bulk or length of the hair interfere with the performance of assigned tasks or duties.
  - 6.4.2. Cosmetics Cosmetics, perfumes and lotions shall be neatly and sparingly applied.
  - 6.4.3. Fingernails Fingernails shall be well manicured and neat and the length shall not interfere with the performance of assigned tasks or duties.
- 6.5. Exceptions Subject to the approval of the Police Chief, the provisions of this General Order do not restrict deviation from established policies on personal grooming for the performance of special assignments.
