Submittal for Testing and Approval

A. Scope

The following guidelines are provided to clarify the submittal requirements for approving plastic channelization drums according to T-31-14 of the Traffic Commodity Specifications.

B. Procedure

When submitting a plastic channelization drum to the Department, the following shall be included with the material:

- 1 of each plastic channelization drum,
- The specific product brand name,
- Technical Data Sheet,
- The Manufactures self-certification letter stating each device meets the NCHRP 350 or MASH requirements for its respective category and test level and shall include a detailed drawing of the device,
- A signed letter stating the subject material will not be changed without written notification to the Department,
- Contact person's name, title, address, email address, and phone number, and
- Acknowledgement by Company form <u>BMPR 101</u>.

The sample and submittal information shall be sent to:

When a sample is submitted, it will be tested for Dimensions, Color, and Composition in accordance with T-31-14.

C. Recertification

Recertification of all Plastic Channelization Drums is required every two years or when a change is made to the manufacturing process.
