In undertaking this obligation, I hereby **waive any and all exemptions** that I may have under state or federal law, including but not limited to, exemptions from attachment, levy or execution of or upon personal or real property, including my homestead. I further agree that any dispute or action arising from this agreement that is cognizable by a court of law shall be submitted to the Circuit Court of Calhoun County, Alabama, sitting without a jury, which Court shall have exclusive jurisdiction and venue of the same. This undertaking may not be delegated to any person or entity not a party hereto without the written permission of Jacksonville State University.
