When needed, the agency authorizes overtime.

During the onsite audit, a review of the agency policy, staff interview, and the agency's current staffing plan indicate all the elements are in place. The Auditor noted video monitoring technology is well placed throughout the facility, all housing areas have large windows for staff direct line of sight supervision and/or open metal bar walls for direct sight and sound observation that enhances the supervision and safety of the inmates. Together this exceeds this standard.

Inmates interviewed reported staff of the opposite gender do announce themselves and that they would never be in a state of undress in front of opposite gender staff.

A review of the agency policy, staff and inmate interviews, and observations of staff announcing themselves when entering a housing unit with inmates of the opposite gender has demonstrated every precaution is made to ensure inmates are afforded privacy when using the toilet, showering, and changing clothes.
