- A. DSS Client System provides information from Foster Care, non-IV-E Foster Care, * SNAP **, FITAP/KCSP and Medicaid files.
- B. Department of Public Safety and Corrections provides information from drivers license records, vehicle registration, as well as juvenile and adult correction files. DPSC interface is updated quarterly. For more current information access CAJUN manually.
- C. Interstate Data Exchange Consortium (IDEC) provides on-line access to participating states' wage and unemployment, motor vehicle, food stamp, and correction files. Louisiana has linked with other states to provide immediate locate information. States participating as of January 2008 are South Carolina, North Carolina, Tennessee, Alabama, Georgia, Kentucky, Arkansas, Louisiana, Virginia, West Virginia, Delaware, New Mexico, Oklahoma, Pennsylvania, and South Dakota. These states are not all full members and may not all participate in both locate and/or FIDM data exchange.
- D. Other states' Parent Locate Service (PLS). The [OMB Locate Data Sheet](#) is used to request "quick locate" if CSENet is not available. The request may be sent directly to the responding state's PLS. "Quick locate" is useful if it is believed that a parent may be in one of several states, but the correct state has not been verified.
