INSTRUCTIONS FOR EXECUTING INSTALLMENT AGREEMENT

- 1. Installment agreement forms must be executed in triplicate. One copy is retained by the installment debtor (person making payment); one copy is retained by the installment creditor (person receiving payment); and one copy must be forwarded to the Office of Motor Vehicles.
- 2. If insurance company or attorney signs as agreement in behalf of their insured or client, it must be designated that they are representatives of that party.
- 3. If the installment agreeme nt includes the insured's portion of the deductible, the insured's name is to be included. If the insured's deductible portion is not included, a separate agreement must be executed with the adverse party or other approved compliance made by the party of the first part.
- 4. The agreement must be signed by both the installment debtor and creditor and must be signed in the presence of two witnesses over eighteen years of age. If there are no witnesses, the form must be signed by and in the presence of a Notary Public.
- 5. Should there be a default in this agreement and this office is notified by the installment creditor to this effect through correspondence, this office will issue an order of suspension which will remain in effect until security is deposited in the amount as determined by the Office of Motor Vehicles or until full payment is made or a full and unconditional release is obtained by the installment debtor, and a reinstatement fee of \$25.00 will then be required before the privileges of the installment debtor may be restored.
- 6. Security deposits with this office cannot be made on the installment basis.
