600.67 — POLICE SOCIAL WORKER

Operational Procedure Effective Date: 03/2024 Rescinds: 07/2019

PURPOSE

This procedure is to establish guidelines for the Lansing Police Department Police Social Work Program in their mission to provide citizens in need with information to properly access individualized care, support, and other appropriate community services. Police Social Workers (PSW) do not provide treatment or therapy. PSWs engage in crisis intervention, welfare checks, needs assessments, and referrals to community service providers. The goal of the PSW Program is to reduce unnecessary law enforcement interactions with persons experiencing mental or behavioral health issues, substance use disorders, unhoused persons, or other social service needs by increasing the quality of life for these individuals through connections to resources and supports.

DEFINITIONS

- Follow Up For purposes of this procedure, "follow up" means any communication after a referral for social services is made. Follow up may include any of the tasks performed by PSWs described elsewhere in this procedure.
- Liaison For purposes of this procedure, "liaison" refers to the role of the PSW in connecting individuals with resources and social services available in the community.
- **Police Social Work** Work performed on behalf of and in concert with a Law Enforcement agency concerning the aid of economically, physically, mentally, or socially disadvantaged persons in the community, with the goal of reducing incarceration and repeated interactions with Law Enforcement.
- **Police Social Worker (PSW)**: LPD personnel, licensed through the State of Michigan as a Licensed Master of Social Worker (LMSW or LLMSW), and trained to assess and serve suicidal persons, those with mental illnesses or substance use disorders, and other similar vulnerable populations.
- **Treatment Relationship** For purposes of this procedure, a "treatment relationship" is defined as the managed care of an individual for purposes of gathering information, diagnosing, and making plans regarding the health of the individual. This fiduciary relationship creates a duty of care and is subject to applicable confidentiality laws.

OPERATIONS

- PSWs will adhere to LPD Policy and Procedures and to the guidelines provided in the <u>LPD PSW</u> <u>Training Manual</u>.
- PSWs will check in for service at the start of their shifts with Ingham County Central Dispatch and are expected to respond to calls for service from officers on scene and to follow up on referrals made to the PSW Program.
- PSW Services:
 - In addition to any call or incident involving a behavioral or mental health component, the PSWs can also help with a variety of other situations, including but not limited to:
 - Substance use concerns
 - Crisis intervention and trauma response

86	Act as a liaison between citizens, the Lansing Police Department, community agencies, and other

- Assist as needed with coordinating and conducting defusings and/or debriefings following critical incidents.
 Assist officers with conducting crisis intervention on scene and through follow up contact with clients after receiving referrals.
 Conduct welfare checks and needs assessments to provide appropriate referrals to available
 - community services.
 Participate in community trainings, events, and meetings to learn about resources and services
 - Participate in community trainings, events, and meetings to learn about resources and services available in the Lansing area and to connect with other providers to better serve Lansing residents.
- Perform proactive outreach and follow up to assist unhoused individuals. Identify locations
 throughout the City where the most chronically unhoused congregate and open dialogue with these
 individuals to determine if services are required.
 - Facilitate social service-related training for police officers and social agencies.

- Provide crime victims and their families with counseling referral service information and coordinate resource referrals with LPD Victim Advocates and CARE staff as needed.
- Update and maintain the PSW Discussion page and the Active PRT list in the current LPD intelligence sharing database, to provide officers with relevant health and safety information for clients being served by the PSW Program.
- Maintain confidential information in compliance with the <u>National Association of Social Worker</u> (<u>NASW</u>) Code of Ethics, <u>HIPAA</u>, <u>42 CFR Part 2</u>, and other applicable Michigan Public and Mental Health Code compliance (see <u>Public Act 258 of 1974</u> for the Mental Health Code and Part 185 of <u>Public Act 368 of 1978</u> for the Public Health Code referring specifically to Social Work). The PSW has discretion on the release of confidential information about citizens in accordance with the aforementioned laws.
 - The law governing social work practice in the State of Michigan is found in the Public Health Code, especially <u>MCL 333.18501</u> et seq.
 - The rules governing social work practice in the State of Michigan are found in the Administrative Rules of the Michigan Board of Social Work, <u>R 338.2901</u> et seq.
 - At the direction and approval of the Chief or designee, the PSW will advocate for policy changes that will assist the Lansing Police Department in providing services to citizens.
 - The PSW will not provide therapy or engage in treatment relationships with citizens or clients in the scope of this position. PSWs will adhere to the <u>NASW Code of Ethics</u> and other applicable laws on appropriate and professional relationships with clients.
 - The PSW Supervisor will submit monthly activity and annual reports as required by the Patrol Division Commander and Chief of Police.
 - PSWs will complete timely documentation of calls and referrals for service, interactions with clients, and other duties conducted while at work. Collected data will be used to track program activity, evaluate performance, and conduct program improvement planning.

Appendix A

SOCIAL WORK GRID FOR SCOPE OF PRACTICE

This grid is intended as a guide to assist PSWs in understanding the differences in the levels of regulation and to show who would typically be responsible for various activities and functions. This grid is not an authoritative restatement of the law or regulations governing the practice of social work in the State of Michigan. Yes categories listed in red show what tasks/functions LPD PSWs are currently authorized to perform; all remaining are allowable under Statue and Administrative Rule but not allowed per this procedure.
