The killing of another person through gross negligence or without malice.

0900-4 JUSTIFIABLE HOMICIDE

The killing of a perpetrator of a serious criminal offense by a peace officer in the line of duty; or the killing, during the commission of a serious criminal offense, of the perpetrator by a private individual.

NOTE: A "serious criminal offense" is a felony or high misdemeanor.

0900-5 DEATH INVOLVING USE OF FORCE BY LAW ENFORCEMENT

0900-6 IN-CUSTODY DEATH

Once the investigation has been completed and the prosecutor has made a determination, an additional offense file class of 09001 (Homicide) or 09004 (Justifiable Homicide) should be added to the incident, with applicable MICR edits. Adding the second file class after prosecution, rather than changing the offense file class, will ensure that we have the ability to pull statistics from MICR for the new offenses.

This data will **not** be published on the Michigan State Police Dashboard.

KIDNAPPING/ABDUCTION VIOLATIONS

The unlawful seizure, transportation, and/or detention of a person against her/his will, or of a minor without the consent of his/her custodial parent(s) or legal guardian.

The unlawful taking away of another person using force, persuasion, misrepresentation, false promise, or the like, to serve as a hostage for ransom or reward, or with any other intent.

1000-2 PARENTAL KIDNAPPING

The taking or retention for more than 24 hours his/her child(ren), with the intent to detain said child(ren) from the other parent or legal guardian of the child(ren) who had lawful right to custody or visitation of the child(ren) at the time of the taking or retention.

SEXUAL ASSAULT - FORCIBLE

Any sexual act directed against another person, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent.

Force or coercion can be used or threatened. Use of authority can be a form of coercion.

(Refer to CSC statute for definitions.)

- NOTE: The offense could possibly be 3600-1 Sexual Penetration Non-forcible Blood/Affinity if the following circumstances exist:
 - 1. The victim is 13, 14, or 15 years of age **AND**
 - The actor is a member of the same household or related by blood or affinity <u>AND</u>
 - 3. Force or coercion was **NOT** involved.

The offense could possibly be 3600-2 Sexual Penetration Non-forcible Other if the following circumstances exist:

- 1. The victim is 13, 14, or 15 years of age AND
- 2. Force or coercion was **NOT** involved.

1100-1 SEXUAL PENETRATION PENIS/VAGINA - CSC 1ST DEGREE

The sexual intercourse of a person, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her temporary or permanent mental or physical incapacity.

NOTE: Sexual intercourse is defined as penetration of the vagina by the penis.

1100-2 SEXUAL PENETRATION PENIS/VAGINA - CSC 3RD DEGREE

The sexual intercourse of a person, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her temporary or permanent mental or physical incapacity.

CSC 3rd Degree - Penetration Penis/Vagina1172

1100-3 SEXUAL PENETRATION ORAL/ANAL - CSC 1ST DEGREE

Oral or anal sexual penetration with another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

CSC 1st Degree - Penetration Oral/Anal......1173

1100-4 SEXUAL PENETRATION ORAL/ANAL - CSC 3RD DEGREE

Oral or anal sexual penetration with another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

CSC 3rd Degree - Penetration Oral/Anal1174

1100-5 SEXUAL PENETRATION OBJECT - CSC 1ST DEGREE

To use an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

CSC 1st Degree - Penetration Object1175

1100-6 SEXUAL PENETRATION OBJECT - CSC 3RD DEGREE

To use an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

CSC 3rd Degree - Penetration Object......1176

1100-7 SEXUAL CONTACT FORCIBLE - CSC 2ND DEGREE

The intentional touching of the intimate body parts of another person for the purpose of sexual arousal or gratification, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

1100-8 SEXUAL CONTACT FORCIBLE - CSC 4TH DEGREE

The intentional touching of the intimate body parts of another person for the purpose of sexual arousal or gratification, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

CSC 4th Degree - Forcible Contact......1178

1200-0 ROBBERY

The taking or attempting to take anything of value under confrontational circumstances from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear of immediate harm.

NOTE: Because some type of assault is an element of the crime of Robbery, an assault should not be reported as a separate offense as long as it was performed in furtherance of the robbery. However, if the injury results in death, a Homicide offense must also be reported.

ASSAULT

An unlawful attack by one person upon another.

- NOTE: Careful consideration of the following factors should assist in classifying assaults:
 - 1. The type of weapon employed or the use of an object as a weapon;
 - 2. The seriousness of the injury;
 - 3. The intent and capability of the assailant to cause serious injury.

Usually, the weapon used or the extent of the injury sustained will be the deciding factors in distinguishing aggravated from nonaggravated assaults. In only a limited number of instances should it be necessary to examine the intent and capability of the assailant. (UCR Handbook, NIBRS Edition)

1300-1 NONAGGRAVATED ASSAULT

An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

1300-2 AGGRAVATED/FELONIOUS ASSAULT

An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.

To unlawfully and intentionally damage, or attempt to damage any real or personal property by fire or incendiary device.

2100-0 EXTORTION

To unlawfully obtain money, property or any other thing of value, either tangible or intangible, through the use or threat of force, misuse of authority, threat of criminal prosecution, threat of destruction of reputation or social standing or through other coercive means.

BURGLARY/BREAKING & ENTERING

Unlawful entry into a building or other structure; or possession of burglary tools. Structure includes but is not limited to: apartment, barn, cabin, church, condominium, dwelling house, factory, garage, housetrailer or houseboat (used as permanent dwelling), mill, office, other building, outbuilding, public building, railroad car, room, school, stable, vessel (ship), and warehouse.

NOTE: Incidental damage resulting from a Burglary (e.g., a forced door, broken window, hole in wall, dynamited safe, etc.) is to be reported <u>only if</u> the amount of damage is deemed <u>substantial</u> by the reporting agency. If deemed substantial, the damage is to be reported under file class 2900-0 Damage to Property.

Property stolen in connection with a Burglary/Breaking & Entering is to be reported as part of the Burglary and not as a separate offense of Larceny.

The illegal entry of a tent, tent trailer, motorhome, housetrailer, or any other mobile unit being used for recreational purposes, followed by a theft, felony, or attempt to commit a felony or theft, should be classified as larceny.

Breaking and Entering of a Motor Vehicle is classified as 2300-5 Larceny - Theft from Motor Vehicle

2200-1 BURGLARY - FORCED ENTRY

Unlawful forcible entry of a building or other structure with the intent to commit a theft or felony. Does not apply to autos or coin boxes.

2200-2 BURGLARY - ENTRY WITHOUT FORCE (Intent to Commit)

Unlawful entry without force with the intent to commit a theft or other felony.

2200-3 BURGLARY - ENTRY WITHOUT AUTHORITY, WITH OR WITHOUT FORCE (No Intent)

Entry without intent to commit a theft or other felony.

2200-4 POSSESSION OF BURGLARY TOOLS

Possession of a tool or implement designed for breaking and entering.

LARCENY VIOLATIONS

The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.

NOTE: Larceny violations which involve shoplifting are classified as 3000-2 Retail Fraud - Theft.

2300-1 LARCENY - POCKETPICKING

The theft of articles from another person's physical possession by stealth where the victim usually does not become immediately aware of the theft.

2300-2 LARCENY – PURSE SNATCHING

The grabbing or snatching of a purse, handbag, etc., from the physical possession of another person.

NOTE: If more force was used than actually necessary to wrench the purse from the grasp of the person, then a strong-arm Robbery occurred, rather than Purse Snatching.

2300-3 LARCENY - THEFT FROM BUILDING

A theft from within a building which is either open to the general public or where the offender has legal access.

2300-4 LARCENY - THEFT FROM COIN-OPERATED MACHINE/DEVICE

A theft from a machine or device which is operated or activated by the use of coins.

2300-5 LARCENY - THEFT FROM MOTOR VEHICLE

The theft of articles from a motor vehicle, whether locked or unlocked.

2300-6 LARCENY - THEFT OF MOTOR VEHICLE PARTS/ACCESSORIES

The theft of any part or accessory affixed to the interior or exterior of a motor vehicle in a manner which would make the item an attachment of the vehicle, or necessary for its operation.

2300-7 LARCENY - OTHER

All thefts which are not specifically defined in the Larceny subcategories listed above.

NOTE: This includes thefts from fenced enclosures, boats, and airplanes. Thefts of animals, lawnmowers, lawn furniture, hand tools, and farm and construction equipment are also included where no break-in of a structure was involved.

MOTOR VEHICLE THEFT/FRAUD VIOLATIONS

The unlawful taking or driving away of a motor vehicle. Receiving or transporting stolen motor vehicles. Fraudulently obtaining money or goods under false pretenses.

NOTE: Aircraft theft is classified as 2300-7 Larceny - Other.

Theft of motor vehicle parts/accessories is classified as 2300-6 Larceny - Theft of Motor Vehicle Parts/Accessories.

Carjackings are classified as 1200-0 Robbery.

2400-1 MOTOR VEHICLE THEFT (Reported by your jurisdiction)

Theft of a self-propelled motor vehicle that runs on the surface of land and not on rails. Includes mopeds and snowmobiles.

2400-3 MOTOR VEHICLE FRAUD

Intentional misrepresentation of the truth to obtain money, goods, or other things of value involving motor vehicles.

NOTE: This file class includes offenses which involve the theft of motor vehicles to defraud insurance companies, re-tagged motor vehicles, and all owner give-ups during narcotics trafficking.

2500-0 FORGERY/COUNTERFEITING

The altering, copying, or imitation of something, without authority or right, with the intent to deceive or defraud by passing the copy or thing altered or imitated as that which is original or genuine; or the selling, buying, or possession of an altered, copied, or imitated thing with the intent to deceive or defraud.

FRAUDULENT ACTIVITIES

The intentional perversion of the truth for the purpose of inducing another person, or other entity, in reliance upon it to part with some thing of value or to surrender a legal right.

NOTE: The most specific subcategory of fraud should be reported whenever the circumstances fit the definition of more than one of the subcategories listed below. For example, most frauds would fit the definition of False Pretenses/Swindle/Confidence Game. But, if a credit card was used to perpetrate the fraud, the offense would be classified as Credit Card/Automatic Teller Machine Fraud.

Fraud offenses which involve motor vehicle thefts should be classified as 2400-3 Motor Vehicle Fraud.

The intentional misrepresentation of existing fact or condition, or the use of some other deceptive scheme or device, to obtain money, goods, or other things of value.

2600-2 FRAUD - CREDIT CARD/AUTOMATIC TELLER MACHINE

The unlawful use of a credit (or debit) card or automatic teller machine for fraudulent purposes.

Falsely representing one's identity or position, and acting in the character or position thus unlawfully assumed, to deceive others and thereby gain a profit or advantage, enjoy some right or privilege, or subject another person or entity to an expense, charge, or liability which would not have otherwise been incurred.

2900-0 DAMAGE TO PROPERTY

The willful or malicious destruction, damage, injury, disfigurement, or defacement of any public or private property, real or personal, without the consent of the owner or person having custody or control.

NOTE: This offense is to be reported <u>only if</u> the reporting agency deems that <u>substantial</u> injury to property has occurred. The offense includes a broad range of injury to property, i.e., from deliberate, extensive destruction of property at one extreme to mischievous less extensive damage at the other extreme. It does not include destruction or damage to property caused by the crime of Arson.

3000-1 RETAIL FRAUD - MISREPRESENTATION

To alter, transfer, remove and replace, conceal, or otherwise misrepresent the price at which property is offered for sale, with the intent not to pay for the property or to pay less than the price at which the property is offered for sale.
