DELAWARE STATE POLICE / NEW CASTLE COUNTY POLICE FUNCTIONAL AND JURISDICTIONAL RESPONSIBILITIES AGREEMENT FOR NEW CASTLE COUNTY

- 1. This agreement provides the basis of the functional and jurisdictional responsibilities in New Castle County.
- 2. Every effort shall be made to comply with the intent of this agreement; however, when a case arises which is not dispatched within the scope of the agreement, the complaint mask shall be identified by placing "N-A" on the complaint screen.
- 3. Every member of the division shall strive to improve the working relationship between the Division of State Police and New Castle County Police. The goal of this program is to provide the citizens of New Castle County the best police service available. All members shall work toward this goal.
- 4. History Not withstanding the modifications contained herein, this agreement represents the provisions contained in other agreements between the parties hereto, described as follows:
 - A. Agreement between the Governor of the State of Delaware and County Executive of New Castle County, Delaware, for Pilot Jurisdictional Program in New Castle County, November 1, 1975, to February 1, 1976.
 - B. Agreement between the Governor of the State of Delaware and the County Executive of New Castle County, Delaware, for a continuation of the Pilot Jurisdictional Program in New Castle County, effective February 2, 1976.
 - C. Agreement between the Governor of the State of Delaware and the County Executive of New Castle County, Delaware, for an amendment of the Police Jurisdictional Program in New Castle County, effective April 1, 1979.
 - D. Agreement between the Governor of the State of Delaware and the County Executive of New Castle County, Delaware, for an amendment of the Police Jurisdictional Program in New Castle County, effective May 1, 1981.
- 5. Purpose To define the functional and jurisdictional responsibilities of the Delaware State Police and the New Castle County Police in New Castle County in order to provide improved police service in a coordinated approach to public safety.

6. Scope – This agreement extends to all areas within New Castle County with the exception of those incorporated areas having contractual agreements with either the County Police or State Police for full time police coverage. In cases of this nature, the police agency under contract will have primary jurisdiction over police functions.

7. Functional Responsibilities for Police Service

- **A. Delaware State Police** The Delaware State Police shall have primary responsibility for patrolling and investigating requests for police services on interstate highways, freeways, U.S. Route numbered highways, Delaware route numbered highways, primary roads, secondary roads and the abutting residences, commercial establishments, industrial sites and other structures along said roadways. Roadways under the State Police jurisdiction are identified on the attached list which has been approved by the two police agencies. The Delaware State Police shall have primary responsibility for the delivery of police service in incorporated cities or towns, south of the Chesapeake and Delaware Canal. In the event any incorporated city or town agrees to pay New Castle County taxes that would offer police coverage, this portion of the agreement will be reexamined. The Delaware State Police shall have primary responsibility for the delivery of police service on the Delaware River and Bay, the Chesapeake and Delaware Canal Wildlife Area, U.S. Reservations, and all railroad property with the exception of railroad property within the incorporated limits of Middletown. The Delaware State Police will have primary responsibility for any construction site which is primarily commercial or industrial in nature and any commercial or industrial location which abuts on at least one side or has direct access from any road under their primary responsibility. The Delaware State Police will have primary jurisdiction over the delivery of police services within all schools, both public and private.
- **B. New Castle County Police** The New Castle County Police shall have primary responsibility for patrolling and investigating requests for police service on those roadways described on the official list approved by the two police agencies (see attached list), including commercial, industrial and residential areas abutting those roadways. The New Castle County Police Department will have primary responsibility for providing police service in residential developments. The New Castle County Police will have primary responsibility for patrolling and investigation requests for police services in residential apartment complexes, mobile home

(trailer) parks, and any construction site which is primarily residential in nature. The New Castle County Police shall also have primary responsibility where two or more homes share a common private drive or roadway (or a common address) off of a roadway under State Police jurisdiction identified on the attached list.

C. Joint Areas of Acknowledgement not covered by Paragraph A or B

- 1. When a call for police service occurs in an area which does not fall clearly within the definition of Paragraph A or B, it shall be investigated by the nearest available patrol unit, regardless of the police agency.
- 2. When the appropriate patrol unit is not available or in the immediate vicinity of a serious crime reported to be in progress, or an incident which has or it likely to result in serious physical injury, the nearest police unit will be dispatched regardless of the police agency. The subsequent investigation of such complaints will be conducted by the appropriate agency, as set forth in Paragraph A and B, unless deadly force is directed at or used by the initial officer on the scene. In such cases, the officer's department will have primary jurisdiction for the entire investigation.
- 3. The Delaware State Police will have primary responsibility for investigating incidents which occur at or within any intersection where a road under the jurisdiction of the County Police meets a road under the jurisdiction of the State Police. (Roadways under the State jurisdiction will be considered primary and will be predominant in determining the investigation of any occurrence.)
- 4. The Delaware State Police will have primary responsibilities for patrolling and investigating calls for service at the Chemical complexes surrounding the Delaware City Refinery, and any construction site which is primarily commercial or industrial in nature and any commercial or industrial location which abuts on at least one side or has direct access from any road under their primary responsibility, as directed in Paragraph A.
- 5. When a police unit, while on his/her duty tour, witnesses a criminal act in progress, which has not been reported and makes an apprehension, the following jurisdictional policy shall be utilized:

- a. The agency for which said officer works will have primary investigative responsibility for that incident.
- b. When such investigations are conducted, the investigating agency will be responsible for notifying the other agency of the investigation. Such notification shall be made expeditiously. In addition, a report of investigation will be supplied to the other agency as soon as possible.
- 6. Aviation accidents will be investigated by the agency with primary responsibility for providing police services in the area of initial point of impact.

D. Vice and Organized Crime

- 1. The Delaware State Police will have the primary responsibility for the control and investigation of vice and organized crime in New Castle County.
- 2. The New Castle County Police will conduct investigations of vice and organized crime only as it relates to their primary responsibility of providing residential police service to the communities of New Castle County. The investigations will be coordinated wherever possible with the appropriate units of the Delaware State Police.
- 3. Information and resources shall be freely exchanged between members of both departments.

E. Narcotic and Dangerous Drug Enforcement

- 1. The agencies acknowledge that the effect of drug law violations is both a statewide and community-level law enforcement problem. Therefore, it is agreed that both departments will maintain an active program for the detection and apprehension of drug law violators at their respective level.
- 2. The Delaware State Police and New Castle County Police will coordinate their investigations wherever possible. Information and resources shall be freely exchanged between members of both departments.

8. Governmental Functions

A. The agencies acknowledge that police service or investigations of crimes occurring in State-maintained institutions, parks and Governmental functions will be the primary responsibility of the Delaware State Police.

B. The agencies acknowledge that police service or investigations of crimes occurring in County-maintained institutions, parks and Governmental functions will be the primary responsibility of the New Castle County Police.

9. Miscellaneous Functions

A. Juveniles

- 1. The agencies acknowledge that the Delaware State Police and the New Castle County Police both maintain units engaged in the investigation of juvenile complaints, delinquency prevention and maintaining liaison with civic organizations and other agencies.
- 2. The Delaware State Police shall have the primary responsibility for police service within any school or on school property.
 - a. For the purpose of this section, "school" shall be defined as any public or private institution for the education and instruction of children or young adults.
 - b. "School property" shall be defined as any school building, grounds, athletic field, maintenance buildings, administration building or school construction sites.
 - c. All day care centers and closed school buildings, either abandoned or converted to other non-educational uses, will be handled in accordance with the jurisdictional agreement by location.
- 3. The Delaware State Police shall have primary responsibility for police service for any alleged incident which is reported to have occurred within the confines of any school bus, regardless of the location or time of day, when being used in a school sanctioned activity.

B. Other Assistance

1. In the event assistance in matters of public safety is requested by the Chief Executive of an incorporated area of New Castle County, such assistance shall be the primary responsibility of the agency who receives such requests.

In signing this document, the parties certify that they are in full accord with the provisions contained herein. The effective date of this agreement will be January 1, 1999.
