Tribal Commissions Application and Applicant Checklist

Required Documentation		
Agreement:	Written agreement executed between the Chief of the New Mexico State Police and the Indian nation, tribe or pueblo, or the appropriate federal official with procedures to be followed in the issuance and revocation of commissions and the respective rights and responsibilities of the departments.	
Insurance:	Proof of adequate public liability and property damage insurance for vehicles operated by its peace officers and police professional liability insurance for its police officers. This insurance has to be written by a company licensed to sell insurance in New Mexico. (The Bureau of Indian Affairs is not subject to this provision.)	
Training:	The Tribal, Pueblo, or Bureau of Indian Affairs' Peace Officer must obtain a New Mexico Peace Officer Certification from the Director of the New Mexico Law Enforcement Academy, pursuant to Sections 29-7-1 through 29-7-11, N.M.S.A, 1978. Attach a copy of your CERTIFICATION from the Director of the New Mexico Law Enforcement Academy	
Photo:	A digital photo of applicant in full dress uniform with American Flag in the background and copy of the agency's badge (jpeg format). Images may be emailed to the Training and Recruit Bureau or may be submitted on electronic media storage at the time of application submission.	
Signature:	A signature version of the applicant's name in black marker to capture digitally. (see attached form)	

Please note that all applicants will be viewed through Triple I and the NMLEA Employee Peace Officer Standards and Training (POST) Profile. Any issues that arise which are in direct violation of the NMLEA will be brought to ypur agencies attention as well as the Chief of the New Mexico State Police.
