### **VIOLATIONS OF VEHICLE CODE SECTIONS 12500 AND 14601**

The purpose of this Training Bulletin is to set forth Department policy and procedure for citing persons driving with a suspended driver's license or no driver's license, and details the proper procedures for determining the status of a driver's license.

Effective immediately, the citing officer shall determine the status of an offender's driver's license at the time of the traffic stop and, if appropriate, cite the offender.

When the offender's driver's license status can be determined or verified, a 14601 VC or 12500(a) VC violation shall be cited as an infraction unless citing/arresting as a misdemeanor is the more appropriate course of action. The following 14601 VC sections apply:

14601.1(a); 14601.2(a); 14601.2(b); 14601.3(a); 14601.4(a); 14601.5(b)

### **Driver's License Status**

When a traffic enforcement stop is initiated, the officer must conduct a DMV query via laptop computer or through the Communications Section Service Channel to determine the status of the license.

The DMV Report reflects the status of a driver's license and is classified as one of the following:

- 1. Valid;
- 2. None Issued/Expired;
- 3. Suspended/Revoked;
- 4. Suspended/Revoked: Service Needed; or
- 5. Restricted.

In the event the driver's license status is:

None Issued or Expired

Cite the offender for 12500(a), *Driver, Unlicensed*. Circle the "I" (Infraction) or "M" (Misdemeanor) on the citation, as appropriate. (APPENDIX - Exemplar 1)

Suspended/Revoked/Restricted or Service Needed

Review the reason for the suspension and whether the notice of suspension was properly served. (APPENDIX - Exemplar 2-4)



Locate the most recent reason for suspension (below the license status), the effective date of the suspension (date mailed/served), and the authority for the suspension.

**NOTE**: In the event there are multiple suspensions, make sure to record the information for the most recent suspension. (APPENDIX - Exemplar 4)

Cite the offender for the appropriate 14601 VC (w/ subsection). Circle the "I" (Infraction) or "M" (Misdemeanor) on the citation (See chart below to determine the appropriate 14601 subsection). A citation cannot be issued for a 14601 VC violation that has not been properly served.

### **DMV Report Service Codes**

Locate the SERVICE code on the DMV Report (See DMV Service Codes).

If the DMV Report indicates a Service Code "I" - INCOMPLETE SERVICE **OR** states VERBAL OR PERSONAL SERVICE NEEDED, confiscate the driver's license (if in possession). Complete, issue, and submit a Verbal Notice by Peace Officer (DL 310) form. (APPENDIX – Exemplar 5) NOTE: Form DL 310 is updated approximately every three (3) years. The Traffic Division will ensure that the current version is available.

In the event there is a SERVICE CODE indicating service but the DMV Report also states VERBAL OR PERSONAL SERVICE NEEDED, consider the service as defective. Complete, issue, and submit a Verbal Notice by Peace Officer form.

Remember to have the driver sign the form and provide the driver with the Pink copy. Attach the White copy to the confiscated driver's license and deposit into the Traffic Report Receptacle. The Canary copy is retained for the officer's records.

### **Determining the Appropriate 14601 Vehicle Code Violation**

Once the citing officer has determined the suspension is active/current, the reason for the suspension, and the suspension notice has been properly served, the citing officer shall cite the violator for the appropriate 14601 Vehicle Code section and NOT for 12500 VC.

Use the DMV Report and the chart below to determine the appropriate 14601 VC Subsection to use. (NOTE: a copy of the chart is also located on pg. 10 of the Court Card TF-1024)

Locate the suspension AUTHORITY on the DMV Report. Find the AUTHORITY code in the left column. Issue the citation for the appropriate 14601 VC violation indicated in the middle column.

**IMPORTANT NOTE**: If the AUTHORITY code is not listed on the DMV Report, cite the offender for 14601.1(a) VC.

## Unable to Determine or Verify Driver's License Status in the Field (e.g. record unavailable from DMV, MDT or CLETS is down)

• If the citing officer is unable to determine/verify the offender's license status in the field, issue a citation for 12500(a) VC as a NON-CORRECTABLE INFRACTION.

If after reviewing the DMV Report, the citing officer determines that a 14601 violation is more appropriate, he/she shall complete a citation amendment using the Notice of Correction and Proof of Service Form. (TF-3254) (APPENDIX – Exemplar 6).

- Attach white copy to the citation.
- Place in the traffic citation box.
- Mail pink copy to the person cited and keep the yellow copy for your records.

### Citing the 14601 or 12500(a) Vehicle Code Violation as an Infraction

Complete and issue the citation, unless ineligible, in accordance with the provisions of DGO M-7, CITATIONS FOR INFRACTION OR MISDEMEANOR OFFENSES. Citations shall be completed in accordance with the provisions of Report Writing Manual Inserts N-1, NOTICE TO APPEAR (MISDEMEANOR CITATIONS) and N-2, NOTICE TO APPEAR (TRAFFIC CITATIONS).

No crime report is necessary.

The Traffic Section shall present the citation to the District Attorney's office for approval and routing to the Traffic Court.

### Citing a 14601 or 12500(a) Vehicle Code Violation as a Misdemeanor

In the event the citing officer requests a 14601 or 12500(a) VC violation be charged as a misdemeanor through the District Attorney's Office, he/she shall:

- Complete a Crime and Suspect Report. The Crime Report Narrative must include how the offender was identified;
- Complete a citation. Document the RD Number on the citation;
- The violator's photograph or thumbprint on the back of the citation; or
- The District Attorney has requested the officer record the offender's acknowledgment that he/she was never issued a license or knew that their license had expired, or was suspended, revoked, or restricted.

The following methods to obtain an acknowledgement need to be accomplished during the initial contact with the offender prior to the officer verifying the license status of the offender through DMV (via laptop or through the Communications Section).

- 1. Personal Digital Recording Device (Department issued PDRD);
- 2. Other audio/video device:



- 3. If an arrest is made before determining whether the offender was aware that his/her drivers license was never issued, expired, suspended, revoked, or restricted, any further interrogation requires Miranda before any questioning.
- 4. Remember that officers cannot compel the driver to give a statement regarding knowledge of the expired suspended revoked or restricted license.

The District Attorney's Office will not charge the violation as a misdemeanor if the officer is unable to obtain any evidence of the acknowledgements listed above.

**IMPORTANT NOTE:** If the officer is unable to obtain any of these acknowledgements, cite the offender as an infraction in accordance with the provisions of this order.

• Place the original Crime Report (print a copy if prepared using FBR) with the citation into a Traffic Envelope and place in the Traffic Report Receptacle.

### **Incomplete or incorrect citations/reports**

Incomplete, incorrect citations and/or reports, or failure to indicate as an infraction or misdemeanor resulting in rejection by the court, will be sent back directly to the citing officer for correction/completion.

#### **DMV SERVICE CODES**

- A Certified mail, suspension issued on or after 06-30-95, driver considered properly served once 45 calendar days have passed from indicated service date. In the event the DMV Report shows a SERVICE CODE "A" but the DMV Report also states VERBAL OR PERSONAL SERVICE NEEDED, consider the service as defective. Complete, issue, and submit a DL 310.
- B Served, signed document on file, driver properly served.
- D Personal service document on file, driver properly served.
- H Acknowledged, no signature, driver properly served.
- Returned unclaimed, issue DL 310A, "Verbal Notice by Peace Officer, DMV, or Court Employee."
- J Personal service by an officer, driver properly served.
- L Deceased.
- M Verbal by court, DMV, law enforcement, driver properly served.
