## A. POLICE COMMISSION:

- 1. Facilities Update
  - a. Restoration

The Dispatch Center is the remaining area that requires remediation; however, the police department is not ready to temporarily relocate dispatchers to the redundant dispatch center at Fire Station II. The police department has spent hundreds of thousands of dollars over the years.

# b. Community Policing Facility (CPF) Planning

The Chair reported that the working group will present at the September 23<sup>rd</sup> City Council meeting on the progress made to the design and development of the plan for a new police facility. The public is welcome to attend and provide their input.

- 2. Community Priorities
  - a. CAD/RMS Update (Central Square)

Training is currently underway in anticipation of an early October 2024 launch of the new Central Square Pro Suite CAD/RMS software. The next focus will be the implementation of a new bodyworn camera program. The department will seek a federal grant for \$220,000 with a 50% match to fund the program.

# 3. Crime Analyst Report

Deputy Chief Maloney reported the calls for service statistics, comparing September 2024, year-to-date, to 2023 totals: Arrests & DWI arrests increased. Involuntary Emergency Admissions (IEAs), mental health calls, juvenile-related calls, accidents, reports taken and calls for service all decreased.

# 4. Monthly Traffic Stats

August 2024: 492 motor vehicle stops, 18 summonses, and 55 reportable motor vehicle crashes.

# 5. Financial Report

FY24 budget update: \$240,000 was returned to the city's general fund due to vacancies.

FY25 budget update: tracking 1.6% below the cap due to vacancies. The FY26 budget planning process has begun; CIP items requested.

- a. Grant Applications Update
  - Federal ICAC grant: Oct 1st.
  - JAG Grant for \$11,000: deciding how it will be used. This grant is administered through Rockingham County (due in Oct).
- **b. Strategic Plan Update** Currently being drafted.
