Message From the Chief of Police

The men and women of the St. Louis County Police Department are committed to maintaining the highest standards of excellence in all facets of policing so that we are considered by our community and our profession as one of the premier law enforcement agencies in the nation. While the St. Louis County Police Department is not the sole provider of services within our community, we realize we are often the initial point of contact between our citizens and the government that serves them. The St. Louis County Police and County Government have partnered with several outstanding governmental and nonprofit organizations which provide quality services to members of our community who are in need of additional services. These services include but are not limited to the St. Louis County Prosecuting Attorney's Office Victim Service Division, the Children's Advocacy Center, the YWCA Crisis Intervention Advocacy Service, Legal Advocates for Abused Women (LAAW), and Behavioral Health Response (BHR).

As Chief of the St. Louis County Police Department, I am dedicated to assuring our citizens are aware of the services available to them during and following times of personal crisis.

The Missouri Crime Victims Amendment

The Constitution of the State of Missouri guarantees that as a crime victim you have the right to:

- Be present at all criminal justice proceedings (if the offense is a felony).
- Be informed of and heard at guilty pleas, bail hearings, sentencing, probation revocation, and parole hearings.
- Be informed of trials and preliminary hearings.
- Restitution.
- Speedy disposition and appellate review of the case.
- Reasonable protection from the defendant.
- Information about the escape or release of the accused.
- Information about the criminal justice process.

Access to these rights are provided through the Prosecuting Attorney's Victim Services Division.

Legal Advocates for Abused Women (LAAW)

A domestic violence program that partners with law enforcement and criminal court systems to break the cycle of violence at the earliest possible stage. LAAW serves St. Louis City, St. Louis County, and St. Charles, Jefferson, Lincoln and Franklin Counties.

Based out of the Prosecuting Attorney's Office, the victim service division offers a full range of assistance to crime victims in St. Louis County, which are provided free of charge. These services include: emotional support, emergency assistance, victim compensation information, advocacy, community education information, and referral.

Also known as "Alternatives to Living in a Violent Environment" this agency provides counseling, emergency sanctuary, and other critical services to adults and children impacted by domestic abuse. They have a 24/7 crisis hotline run by specialized staff ready to answer your call.

YWCA Advocacy Services

YWCA partners with the Department to provide services and advocacy for victims of sex trafficking, abuse, and exploitation. Advocates are available 24 hours a day and frequently assist law enforcement.

Children's Advocacy Center

The Children's Advocacy Center provides high quality trauma-focused services to youth, families, and the community. They serve children impacted by all types of traumatic events including childhood sexual abuse, physical abuse, and neglect. They also provide services to witnesses of domestic abuse and violent crime, and children who have suffered accidents, natural disasters, and traumatic bereavement.
