

Q. I am a local firearms instructor and want to be listed as a Missouri CCW instructor on the St. Louis County database for St. Louis County residents only, what do I do?

A. You can pre-register with our office at no cost, however you will need to provide the following: proof of Firearms Safety Instructor as listed in MO Statute 571.111.1, clear copy of government issued ID, and contact information (name, address, phone number).

Q. How do I find a qualified firearms instructor to undergo my required training?

A. Refer to your local gun range to find eligible instructors who will comply with training requirements found in RsMo 571.111.

Q. What do I need to renew my permit?

A. You must be present and provide your current CCW and government issued ID. Cost is \$40.

Q. Can I renew my permit early?

A. Yes

Q. I'm late renewing, do I have to start over?

A. It depends. Renewal is \$40, but if you are a day late to renew, you must pay an additional late fee of \$10 per month for each month the permit is expired. However, if you are more than 6 months late, you will have to redo the application process.

Q. I currently have a Missouri CCW permit and moved from another county to St. Louis, what do I do?

A. You must notify the new county in which you moved to. Also, within 30 days of moving you will need to appear in person with your proof of county address and CCW permit so we can transfer it. The fee for transfers is \$10.

Q. Do I need to register my gun?

A. No, the state of Missouri no longer registers guns. However, we do suggest if you sell or transfer your gun that you keep proof of ownership and refer to your local gun dealer for further advice.

Am I Eligible to Obtain a CCW Permit?

State law outlines in section 571.101 the following requirements for a concealed and carry permit:

- You must be at least 19 years old.
- A citizen of the United States, or assumed residency in this state.
- A member of the armed forces stationed in Missouri, or a spouse of such a member.
- Attended a concealed carry safety class conducted by a certified firearms instructor.
- Have not been convicted or pled guilty to or entered a plea of nolo contendere of a felony crime.
- Not received a suspended imposition of sentence (SIS) for a felony crime.
- Not convicted of, pled guilty to, or entered a plea of nolo contendere to one or more misdemeanor offenses involving crimes of violence within a 5-year period immediately preceding application for a permit to carry concealed.
- Not convicted of 2 or more misdemeanor offenses involving driving while under the influence of intoxicating liquor or drugs or the possession or abuse of a controlled substance within a 5-year period immediately preceding application for a permit to carry concealed.
- Not a fugitive from justice or presently under indictment.
- Not been discharged under dishonorable conditions from the U.S. Armed Forces.

- Not engaged in a pattern of behavior, documented in public records that causes the sheriff to have reasonable belief that the applicant presents a danger to himself or others.
- Not adjudged mentally incompetent or been committed to a mental health facility.
- Currently, not the respondent of a valid full order of protection.

How Do I Apply?

Under RsMo 571.101 Missouri residents who wish to obtain a conceal and carry permit must do so from the county in which they reside. If you are a resident of St. Louis County, you may fill out an application at:

Please enter Headquarters on Central Avenue. You must go through security and a metal detector. Please note headquarters are closed on the weekends and holidays.

Under state law you will be required to:

- Appear in person.
- Provide a valid Missouri Driver's License, Missouri Identification Card, or Military ID with orders. Missouri Driver's Licenses and/or Missouri ID cards must have a current address, no PO box addresses will be accepted.
- Bring proof of residency, such as a utility bill or official government document.
- Must present affidavit or certification that firearms training has been completed (RsMo 571.111).

- Complete an application affirming that all qualifications have been met.
- Pay \$90.00 fee. Unfortunately we do not accept American Express.

What Happens Next?

Once your application is completed, you will be fingerprinted. Your fingerprints will be sent off and a national criminal record check will be conducted. Once the results come back, you will receive a letter from us within 45 days of application, stating your approval or denial. If you are approved, you will bring your letter back to us along with a valid ID and we will provide you with your permit.

Q & A

Q. Will other states recognize my conceal carry permit?

A. Missouri recognizes all valid conceal carry permits. To view states that provide conceal carry reciprocity please visit the Missouri Attorney General's Website at: <https://ago.mo.gov/criminal-division/public-safety/concealed-carry-reciprocity>.

Q. Can I carry a firearm in Missouri while traveling in my vehicle?

A. A person can knowingly possess a concealable firearm in a vehicle if: you are 19 years or older and traveling in a continuous journey peaceably through the state of Missouri. You must be in lawful possession, authority, and control of the firearm. For further please refer to RsMo 571.030.

Q. I got married/lost my ID/moved what do I do?

A. You will need to appear in person with a current ID. For \$8 we can issue a new one.
