On Monday, August 29, 2022, at 11:49 a.m., San Bruno Police Officers responded to an area near the Shelter Creek apartment complex on the discovery of human remains. The human remains were discovered by a utility crew, while working in a wooded area adjacent to the property. An Investigator from the San Mateo County Coroner's Office responded to the scene and took custody of the body. Several days later, the Coroner's Office identified the remains as those of former San Bruno resident Lorie Esposito. Ms. Esposito was reported as a missing person to the San Bruno Police in December of 2019. The San Bruno Police and San Mateo County Coroner's Office continue to investigate this case collaboratively. The cause of death has not yet been determined and remains under investigation, although no foul play is suspected at this time.

On Monday, December 9, 2019, at 11:45 pm, San Bruno Police Officers responded to the Shelter Creek Condominium Complex, located at 701 Shelter Creek Lane in San Bruno, regarding the report of a missing person. Family members reported that 61 year-old San Bruno resident Lorie Esposito had not been seen since November 29, 2019.

Lorie Esposito is 5'2", 130 pounds with gray hair and wears prescription eyeglasses. A clothing description at the time she went missing is not available. Esposito was last contacted on November 29, 2019, and is not believed to be associated with a vehicle at this time.
