PURPOSE:

The purpose of this policy is to establish a set standard for uniform make/model/description to be sworn by members of the Stratford Police Department.

POLICY:

It shall be the policy of the Stratford Police Department that sworn officers wear the approved uniforms set forth in this policy. Uniform inspections will be at the discretion of shift commanders.

PROCEDURE:

It shall be the procedure for the Stratford Police Department to regulate the make, model and manufacturer of uniforms to be worn by sworn officers and animal control officers. This policy will also set a standard of acceptable clothing to be worn by non uniform personnel in order to ensure a professional appearance.

Uniform and Equipment

The following list will constitute the uniform and equipment required upon appointments and which must be maintained in good serviceable condition at all times. These items are subject to inspection to ensure they are serviceable and in compliance with policy and procedure.

Those items indicated by an (*) will be issued by the department and will remain departmental property subject to recall. Normal repairs and/or replacement of departmental property will be at the department's expense, unless personal carelessness is evident. In this case, the individual will be held responsible.

Wearing the Uniform

Authorized Summer/Winter uniforms worn by all officers will be at the discretion of the individual yearround. This does not apply to the wearing of the Class A Uniform for ceremonies or events per the Chief or Deputy Chiefs of Police.

The uniform hat will be worn at the direction of the supervisor for special details and assignments. The hat will be carried with the officer for those times it is needed.

When wearing the uniform hat, it will be placed on the head in such a manner that the hat brim is approximately one and one-half inches above the bridge of the nose. At no time is the hat to be worn on the head in a "cocked" position or in any manner that is unmilitary.

The baseball style hat currently used for road jobs may be used for patrol. The current black knit and fur cap is also authorized for patrol duty in the winter only.

Maintaining the Uniform and Assigned Equipment

Each member of the department will be responsible for the condition, maintenance, and safekeeping of all departmental property and equipment issued or assigned to them. No member will alter, add to, remove or in any way change parts or accessories of any departmental property or equipment without permission of the Chief of Police. No member will relinquish or transfer custody of any item of departmental equipment or property issued to them or any person without notifying the Commanding Officer of such transfer.

Sworn personnel must retain one Class A uniform, which will be worn for official department functions and at other times as authorized by the Chief of Police.

Any uniform trousers that have been previously authorized will be acceptable providing that such uniform trousers would give the exact same appearance as the Class A or Class B trousers. Any uniform trousers purchased after this policy will meet the below standards.

Uniform Specifications and Guidelines

Class A Uniform Pant for all ranks. Class A pants are Unisex.

• Fechheimer #32278, Navy wool blend with the Stratford P.D. Dress Braid (Waist to Hem) Gold and Blue in color.

Class A Uniform for Sergeant, Detective and Patrol Officer.

- Male Long Sleeve Shirt: Elbeco Tex-Trop314 Navy
- Female Long Sleeve Shirt: Elbeco Tex-Trop 9314 Navy

The Class A uniform shirt for all personnel above the rank of Sergeant shall be the same as section above, except white in color.

- Male Long Sleeve: Elbeco Tex-Trop 310 White
- Female Long Sleeve: Elbeco Tex-Trop 9310 White

A regulation Stratford Police shoulder patch and applicable rank will be sewn on each sleeve.

A regulation tie and tie bar must be worn at all times with this shirt.

Uniform Tie

Uniform ties will be Navy # 61, Wool Blend, and will be three inches wide at its widest part. Approved Stratford Police tie bar will be required with this tie. The tie length will be 18 inch or 20 inch Per Officer's Height. Female Version Available for shorter Females

- For officer's safety, ties will be clip-on or break away style
- Knit ties will not be allowed
- Detectives will wear proper business ties

Uniform Tie Bar

The approved Stratford Police Tie bar, hook fast #TC-84 with emblem #2220, will be the official style worn with the uniform.

- Patrol Officers will wear silver tie bars
- Uniform Detectives, Sergeants and above will wear gold tie bars
- No other tire bar or tie tack will be worn with the uniform

The tie bar will be worn across the middle of the tie so that the tie bar is exactly even with each side of the tie. This will be in the area between the 3rd and 4th button of the shirt, or just below the bottom of the pocket.

The Class A Hat-Navy P101-80 Visor

Patrol officers will wear a silver band attached with silver P buttons and the patrol hat shield..

Officers the rank of Detective and above will wear a gold band five-eighths of an inch wide on the front of the hat attached with gold "P" buttons and the gold hat shield.

Command Officers Lieutenant and above will have appropriate embroidered gold visor (See illustration Number 10)

Class A Belt

The prescribed belt for a class A uniform will be a leather belt, color black. The buckle on the belt shall be either silver for patrol officers or gold for Detective and above.

Class B Uniform

Class B Uniform Pant- Male Pants: 5.11 Patrol uniform B-Class Twill pants, model 74326, color 750 Midnight Navy or 5.11 Patrol Duty Uniform Taclite B-Class pants, model 74371, color 750 midnight Navy.

Female Pants: 5.11 Patrol uniform B-Class Twill pants, model 64306 / 64310W, color 750 Midnight Navy or 5.11 Patrol Duty Uniform Taclite B-Class pants, model 64371 / 64373W, color 750 midnight Navy.

Any uniform trousers, which fail to meet the above criteria to the satisfaction of the Chief of Police or his designate, will be prohibited.

Class B Uniform Shirt

Male Winter Uniform Shirt: 5.11 Patrol Duty Uniform Class B Long sleeve Twill shirt, Model 72345 in color 750 Midnight Navy. The shirt may be worn over either a plain black crew neck T-shirt, plain black turtleneck or the current black SPD turtleneck.

Female Winter Uniform Shirt: 5.11 Patrol Duty Uniform Class B Long sleeve Twill shirt, Model 62065 62026W in color 750 Midnight Navy. The shirt may be worn over either a plain black crew neck T-shirt, plain black turtleneck or the current black SPD turtleneck.

Winter Uniform Shirt for Evidence Officer: Due to the nature of the assignment, the evidence Officer only is permitted to wear the 5.11 long sleeve professional Tactical performance Polo, Model 72049 in color 724 Dark Navy or the equivalent female version.

Male Summer Uniform Shirt: 5.11 short sleeves Professional Tactical Performance Polo Shirt, Model 71049 in color 724 Dark Navy.

Female Summer Uniform Shirt: 5.11 short sleeve Professional Tactical Performance Polo Shirt, Model 61165 in color724 Dark Navy.

Male and Female Uniform Shirt: 5.11 long sleeve Professional Tactical Performance Polo Shirt, Model 71049-724 in color Dark Navy.

Lieutenants and above Summer Short Sleeve:

- Male: 511 Short Sleeve, 71177, 750 Navy Blue, 010 White
- Females: 511 short sleeve, 61159, 750 Navy Blue, 010 White
- Duty Uniform

This shirt is to be worn open without a tie. While wearing this summer shirt, a T-shirt shall be black in color while wearing the Navy Blue, and White T-shirt when wearing the White polo.

Buttons of the same general color as the shirt material will be used on the shirt front and cuffs of all uniform shirts.

A regulation Stratford Police shoulder patch will be required on both sleeves of all uniform shirts. The patch will be centered on the sleeve one half inch down from the top of the sleeve.

All uniform shirts must have the name and identification number of the officer embroidered on the right breast and the Official Stratford Police Department badge and rank of the Officer (Sergeant and above) embroidered on the badge. Names and identification numbers and badges shall be in silver or gray for all patrol officers and Corporals, gold for detectives and higher-ranking Officers. Rank insignias shall be embroidered on the collars of all shirts for personnel holding the rank of Lieutenant and above. Nothing shall be embroidered on the collars of patrol officers, corporals or sergeants. Rank insignias shall be embroidered on both sleeves of all uniform shirts for the ranks of Corporal and Sergeant.

Class B Uniform Hat

The department authorized baseball cap or class A hat may be worn with the uniform at the officer's discretion unless directed otherwise by a supervisor. The winter knit hat may be worn with the winter uniform.

Uniform Shorts

Uniform shorts have been approved at the chief's discretion for the Marine Unit, Bicycle Patrol and Road Jobs.

- Male Shorts: 373287, 724 Dark Navy Men's Taclite Shorts, 9.5 inseam, or 11" inseam #73308.
- Female Shorts: 63071, 724 Dark Navy Women's Taclite Shorts 9" inseam or Female equivalent.

Winter Thermal Jump Suit

Officers are authorized to wear thermal jump suits during road jobs, or events authorized by a supervisor.

Jump Suit: Topps Thermal Jump Suit Model CO14-1105, Navy Color.

Road Job/Traffic Summer Shirts- Officers will have a choice to wear the Spiewak HI-VIS Yellow Short sleeve polo shirt, model S9T120 or the Blauer HI-VIS Yellow Short sleeve polo shirt, model SS8137. All shirts will have the proper rank and patches per policy.

Dress Code – Detective Division

Winter- All Detectives will wear proper Casual business attire. Business attire will include Suites, Jackets, Ties and shirts and will be worn based on the business of the day at the discretion of a Supervisor. Jeans, sneakers, sweat pants, bib overalls, tank tops, any tops with bare shoulders unless worn with another blouse, top or jacket, novelty or undergarment tee-shirt, novelty or team sweatshirts, athletic or cutoff shorts, athletic shoes, sandals or any open toe shoe will not be worn.

Summer- Proper casual business attire for summer will be required for both male and female detectives.

The wearing of summer and winter attire will coincide with the uniform patrol Division.

The above code may be waived by the commanding officer for special assignments.

Detectives assigned to Special Services, upon the direction from their Commander, or Division Commander, will be exempt from this policy.

All Detectives of this department will consider, with common sense, what current fashion dictates regarding casual business attire. This is done with the deliberate purpose to minimize unconventional, fad, or gaudy style of clothing.

The standard for court will be Business attire.

Nylon Gun Belt Equipment

Gun Belt- The gun belt worn by all uniformed officers will be regulation Bianchi Nylon Duty Gear Accumold 7200, full buckle, two and one-quarter inches wide. The under belt will be black and may be worn with or without a buckle.

Magazine Pouch- The approved Magazine Pouch will be the Bianchi Double Magazine Pouch 7302. It will in be worn on the gun belt to the front of the key ring in a vertical or horizontal position.

Cuff Case- The cuff case will be Bianchi Nylon in style, Single Case 7300. Double Cuff Case 7317 with a Velcro closure flap. Visible outside snaps will not be allowed.

The cuff case is to be worn on the gun belt, on the opposite side from the holster, above the hip, with the flap at the top.

Baton Ring- The ring for the police baton will be black Bianchi Nylon in style.

It will be worn on the gun belt toward the front of the body, next to the cuff case.

Key Holder- A key holder may be worn as optional equipment. If worn, it must be a regulation style with a black snap. The key holder will be worn next to the baton ring toward the front and must be Bianchi Nylon Silent key Holder 7316 in style.

- Line Belt- 7205 Bianchi Nylon Duty Gear (Accumold)
- OC Case- 7307 Bianchi Nylon Duty Gear (Accumold)
- Flashlight Holder- 7311 Bianchi Nylon Duty Gear (Accumold) (Stinger, Strion, Surefire)
- Universal Radio Holder with Swivel- 73145 Bianchi Nylon Duty gear
- Glove Holder (Molded) 7315 Bianchi Nylon Duty Gear

- Glove Holder Flat- 7328 Bianchi Nylon Duty Gear
- Belt Keeper's- 7405k Bianchi Nylon Duty Gear, 7406 Bianchi Duty Gear
- Nylon or Composite Duty Belt and Holster

Holster- Uniformed officers will wear a holster fitting the weapon they carry. It shall meet the following specifications.

The duty holster for the Glock 19/17 will be equipped with an auto lock security system. The holster may be designed and equipped to fit a weapon mounted flashlight. The Holster will fit on a duty belt in such a manner so that the weapon can be safely and easily drawn.

Swivel, tie down, low slung, or cross draw styles holsters are not allowed.

The Holster may be worn on either the right or left side, but not in the cross-draw position. High-rise style holsters should be carefully chosen, as they may be difficult to use when wearing a winter uniform coat.

Jackets and Sweaters

Winter Field Jacket- Blauer jacket is the 9820 in color navy. The coat has several zip in liner options.

- 4650, navy (the standard fleece liner-wind resistant)
- 4660, navy (soft-shell fleece jacket water and wind resistant)
- 4670, high vis/black (color block soft-shell fleece water and wind resistant, certified ANSI Class
 3

The winter field jacket for officers of the Police Department will be the Blauer 9860-50 Hip-Length jacket with zip out Thinsulate liner.

The Blauer 9860-50, Waterproof, and windproof

• The approved cloth badge and embroidered nameplate may be affixed to all service jackets.

Patrol officers will have silver "P" buttons on their jackets when applicable. Detectives, Sergeants, and above will have gold' "P" buttons on their jackets.

A regulation Stratford Police shoulder patch will be worn on both sleeves of all uniform jackets. The patch will be centered on the sleeve one- inch down from the top of the sleeve.

The black "Blauer Model 210 Classic V-Neck Commando" type sweater will be the only sweater worn by uniform personnel.

Specifications for this sweater are as follows: 70/30 blend of low pill acrylic fiber and long –staple wool material, color black, Military style sweater, with cloth elbow pads, cloth epaulets and cloth shoulder pads. Over the right breast area will be a cloth section for a nametag. A badge holder over the left breast area may be sewn on as an option. The sweater will be V-neck and will have1/4" ribs, 2 ribs per inch

- The sweater will be worn inside of the trousers or bloused at the waist so as not to hang over the gun belt.
- The sweater may be worn alone or with the approved jackets.

• No other style of sweater will be allowed either on patrol or inside of the building.

Class A Dress Jacket-Flying Cross #34891 Navy Wool

Blend. Captain's and above

- Gold "P" Buttons per rank
- One (1) Row Stratford P.D. Dress Braid on sleeve
- Regulation Stratford Police shoulder patch on both sleeves.

External Vest Carrier

Sworn personnel, may, at their own option, may purchase and wear and external vest carrier.

- American Body Armor USC1-4 in Navy Blue
- Safariland Tactical Outer Vest Carrier with MOLLE, Navy Blue

Rain Wear

The raincoat for all uniform officers of the Police Department will be the Blauer Defender #733 Reversible raincoat. Full-length reversible raincoat with Blauer exclusive Tech-lite urethane coated oxford nylon with Ultra-Tech factory sealed taped seams. Two-piece stand-up collar, set-in-two-piece sleeves (conform to natural arm-bend) waterproof storm fly over non rusting reversible brass zipper (extra long pull) with nickel on brass snaps, ventilating eyelets under arms, 10" go-through slash pockets for easy access to equipment, badge tabs on both sides. It will be reversible to fluorescent yellow with Scotchlite retro-reflective trim around both cuffs, across back, and down storm fly, 49" long.

The following items are optional rain wear:

- Gortex hat cover (Translucent or Fluorescent Yellow)
- 233 R Blauer Reversible Rain Jacket Color Black
- 134 Blauer Rain Pants Color Black

Optional Cold Weather Wear

Gloves will be black and may be either cloth or leather or a combination of both. Gloves will have full fingers without any cutouts.

Scarves will be plain black.

The optional cold weather hat will be the winter fur type with earflaps, worn with the hat shield.

Black ear protectors made of cloth may be worn.

Winter Thermal Jump Suit - Topps Model CO14 Color 1105

Shoes

Shoes worn by uniformed Officers will be made of black smooth leather, or high gloss man made material, capable of holding a shine.

- The style will be that of a regular shoe, which will include low cut, high cut or 3/4 cut boots.
- All shoes will have a plain, smooth toe.
- Boots worn by Officers will be black in color and may have a zipper on the inner side of the boot.

Laces will be black cloth or leather. No buckles, holes or ornaments will be permitted, but zippers will be allowed on the inside of the boot to facilitate easy use.

Operational Shoes: Uniformed Officers will be allowed to wear the below listed street shoes when working as follows:

Black Only Sneakers with Black shoe laces are authorized while working patrol and road jobs when wearing the authorized department short pants.

Socks

Socks worn by uniformed members will be black without decoration. Members may wear white-soled socks so long as the white does not show above the top of the shoes.

Officers wearing high top boots may wear white socks, as long as they do not show when standing or sitting.

Permission to wear all white socks with low cut shoes will be granted only upon written order by a physician and with approval of the Chief of Police.

Ankle only socks will be authorized to wear while wearing shorts at road jobs. Officer's have choice of wearing White or Black.

Baton

The regulation baton for the Stratford Police Department will be the Monadnock Auto Lock 22" Baton with Power Tip nightstick, without any knobs at the ends.

Because the baton is a valuable police tool, all uniformed patrol officers assigned to the Patrol Division are encouraged to carry their baton while out of the car or while on foot patrol.

Officers may be required to carry their batons at special events if ordered to do so by a command officer.

Name Bar

Members of the Police Department, when in uniform, will display their name bar. It will be centered over the right shirt pocket immediately above and adjacent to the seam of the pocket flap. When wearing a uniform jacket, the name bar will be worn the same as on the shirt, unless there is a name tag holder which will then be used.

The name bar will be approximately 1/2 inch high and, 3 inches long, filled with black enamel with white Block letters. The name bar will have two clutch-back fasteners, or pin to hold it securely to the shirt or jacket.

Patrol officers will wear name bars that have a silver boarder.

Detectives and above, will wear name bars that have a gold boarder.

Block letters with First letter of name, First letter of middle name, and Full last name. Those officers having a rank in front of their name prior to this policy are granted permission to wear same but must comply with above policy when new tags are needed.

Collar Insignias

Patrol Officers, Corporals and Detectives, will wear the Stratford Police patch collar insignia on each collar. The position will be the same as the Lieutenant's bar.

Officers belonging to a specialized unit will wear the approved insignia on the left collar and the-designated unit insignia on the right.

Service Stripes

Service Stripes will be an optional part of the uniform and will be worn only on the uniform jacket.

The service strip will be black with a gold border on a black background and will be approximately 1 1/2 inches long and 3/8 inches wide, not including the black background.

Service stripes will be worn diagonal on the left sleeve of the uniform jacket. They will be worn centered on the sleeve starting approximately three inches up from the bottom of the cuff and continuing vertically up the sleeve.

Those eligible to wear the service stripes are uniformed members of the department with the following service time:

- 4-8 Years 1Stripe
- 8-12 Years 2 Stripes
- 12-16 Years 3 Stripes
- 16-20 Years 4 Stripes
- 20-24 Years 5 Stripes
- 24-28 Years 6 Stripes
- 28-32 Years 7 Stripes

Service stripes may be worn six months prior to the officer's anniversary date. Seniority time for service stripes begins on the date of appointment as a police officer.

Commendation Bars

All officers authorized to wear commendation bars will display them in the order and manner illustrated. They will be worn on the left side of the uniform above the badge. Only those authorized by the Committee and the Chief of Police will be worn. No other BARS will be worn on the uniform.

The pistol award will be worn on the left side of the uniform just below the badge and above the pocket flap.

All other authorized pins, (American Flag, the Town of Stratford pin, F.T.O. pin, EMS certification pin, etc.) will be worn centered above the nametag on the right side of the uniform.

Only (1) pin will be worn at a time.

Pins and bars will be worn in the below order:

- Flag Medal of Valor
- Stratford Life Saving Citation
- F.T.O Merit Award for Excellent Arrest
- E.M.S Police Distinguished Service Medal
- Name Tag Honorable Career Citation
- Military Campaign Ribbons

Badge

A badge holder will be used to display more than one commendation bar. Bars (2 or more) will not be affixed directly to uniform.

All commendations authorized and presented to officers will be worn.

Ceremonial Detail Uniform

All uniformed officers will wear Class A uniforms whenever attending formal police ceremonies, unless specified otherwise by special order.

- Command officers will wear the authorized dress uniform.
- If attending a ceremony conducted by another department, officers will comply with instructions for dress given by that department.

Officers taking part in ceremonies (i.e., pallbearers and rifle squad members) will wear Class A uniforms with hat and white or gray gloves.

- Command officers will wear the authorized dress uniform with white or gray gloves.
- Unless otherwise specified by special order, no jackets will be worn by officers taking part in the ceremony.

Police Building Keys

All members of the Police Department have been issued a key to the Police Building. This key will fit door locks that are normally used in an employee's general area of responsibility.

Since security and safety are the primary concerns, certain procedures must be followed concerning keys so issued.

- Lost keys must be reported in writing immediately to the Chief's Office.
- Duplicate keys may not be made without permission from the Chief of Police.
- Keys may not be loaned to anyone other than authorized Police Department personnel.
- All keys must be returned to the Chief's Office upon termination of employment.

Titles and Rank Insignia

The following titles will be used for officers of the Stratford Police Department:

- Chief
- Deputy Chief
- Captain
- Lieutenant
- Sergeant
- Detective
- Corporal
- Patrol Officer

Rank Insignia

Chief and Deputy Chief of Police - The insignia of the Chief of Police will consist of three gold stars, made in pairs. The insignia for Deputy Chief will consist of two gold stars.

- The shoulder insignia will be 1 inch from tip to tip of stars.
- The collar insignia will consist of one or two gold stars 3/4" width from tip to tip of star. The insignia will have clutch-back type fasteners.

Captain - The shirt insignia of a Captain will consist of two gold bars.

- Shoulder insignia will consist of two gold bars. Each bar will be 1 1/8 inches in length and 3/8 inch in width. They will be parallel and 3/8th inch apart, attached at the ends by 3/32nd inch holding bars
- Collar insignia will consist of two gold bars. Each bar will be 3/4th inch in length and 1/4th inch in width. They will be parallel, 1/4 inch in apart, and attached at the ends by 1/16th inch holding bars.

Lieutenant - The insignia of a Lieutenant will consist of one gold bar.

- Shoulder insignia will be 1 1/8 inches in length and 3/8 inch in width.
- Collar insignia will be 3/4 inch in length and 1/4 inch in width.

Captains and Lieutenants will wear a smooth, no bevel, and style bar on their shirts. Their outer garments will display a Florentine style bar

Sergeant - The insignia of a Sergeant will consist of three royal blue military style sergeant's stripes, bordered in white, on a black background. Stripes will be 3 inches from top to bottom, including the black background, when measured in the center of the stripe. They will also be 3 1/2 inches wide at the widest part, including the black background. Stripes will be of cloth material and sewn on the uniform.

The insignia for Corporal will be the same as the sergeants except that they will consist of two stripes with the appropriate measurements.

Placement of Rank Insignia

Officers will wear only the rank insignia prescribed for their rank.

Rank insignia for the Chief of Police, Deputy Chief, Captains, and Lieutenants will be placed on each shoulder strap of the uniform jacket in the following manner.

Chief of Police - The Chief of Police and Deputy Chief will wear the insignia at a right angle to the centerline of the shoulder strap, with the stars equidistant from the outer edge of the shoulder strap. The center bottom of the insignia will be three- quarters of an inch from the armhole seam.

Captains and Lieutenants - Captains and lieutenants will wear the insignia with the long axis of the bars at a right angle to the centerline of the shoulder strap, equidistant from the outer edge of the shoulder strap. The bars will be in line from front to rear, with the midpoint of the outboard edge three-quarters of an inch from the armhole seam.

Rank insignia for sergeants and corporals will be worn centered on the sleeve of the uniform jacket with the top point of the stripes 1 inch below the Police patch.

Class A shirt - Rank insignia for the Chief of Police, Deputy Chief, Captains and Lieutenants will be worn on both sides of the collar of the Class A uniform shirt. The insignia will be centered between the top and bottom edge c the collar. The leading or forward edge of each insignia will be approximately one-half inch from the front edge of the collar. Rank insignia for sergeants will be worn centered on the sleeve of the Class A uniform shirt below the police patch.

- Chief of Police The Chief of Police and Deputy Chief will place their insignias on the collar, and at their discretion, wear rank insignia in addition on the shoulder strap.
- Captains and Lieutenants Captains and lieutenants will place their insignia so the long axis of the bars is parallel to the front edge of the collar.
- Sergeants and Corporals Sergeants and corporals will place their insignia centered on the sleeve of the Class A uniform shirt one inch below the police patch.

Class B Shirt - Rank insignia for the Chief of Police, Deputy Chief, Captains and Lieutenants will be worn the san as on the Class A shirt.

- Chief of Police The Chief of Police and Deputy Chief, if wearing the Class A or B shirt, will place his insignia on the collar as illustrated.
- Captains and Lieutenants Captains and Lieutenants, when wearing the Class B shirt, will place their insignia so the top of the long axis of the bars' is parallel to the front edge of the collar

• Rank insignia for sergeants and corporals will be worn centered on sleeve of the Class B uniform shirt below the Police patch.

Sergeants and Corporals, when wearing the Class B shirt, will wear their insignia centered on the sleeve and equidistant between the bottom of the Police patch and the bottom edge of the sleeve
