Applications for ETV's and Bright Futures Scholarships are accepted at the beginning of each academic year, and for subsequent semesters or terms of enrollment. Applications for technical programs, others that may have variable enrollment periods, or for students starting an academic program at the second semester or during a summer semester must be reviewed on a case-by-case basis.

Applications should be submitted as follows:

- a) Initial Application deadline is no later than July 15th of the calendar year the youth plans to attend school.
- b) Application deadline for spring semester is December 15th.
- c) Application Deadline for summer school is May 15th.
- d) At least forty-five (45) calendar days before the applicable term begins for vocational or technical programs that have variable start dates.
