Applications should be submitted as follows:

- a) Initial Application deadline is no later than July 15<sup>th</sup> of the calendar year the youth plans to attend school.
- b) Application deadline for spring semester is December 15th.
- c) Application Deadline for summer school is May 15<sup>th</sup>.
- d) At least forty-five (45) calendar days before the applicable term begins for vocational or technical programs that have variable start dates.
- e) Under special circumstances, applications may be accepted at a later date. The circumstances related to late application must be explained here:
