# Waivers to DCFS and State Travel Regulations

# 704 – Family Engagement Across Multiple Systems – The Court as a Catalyst for Change

Central to working in the many youth and family focused court systems is the ability to effectively work with nonvoluntary, resistant, and often difficult to reach youth and families. This presentation will provide an overview of a research driven approach that providers and court personnel can employ to better engage those youth and families. Better engagement equates to better acceptance of recommendations and court orders as well as improved outcomes such as service attainment, participation, and ultimately less need for further sanctioning. Specifically motivational interviewing is a tool that is evidence-based, client-centered, and a directive method of communicating in order to elicit the intrinsic motivation of individuals to explore and resolve their ambivalence to change. The improved connection with youth and families has proven effective in attaining better outcomes in courts, probation services, service provider agencies, and many other venues where people are resistant to the change that is being requested, recommended, and/or directed.
