All inquiries to the District Attorney's Office concerning a "particular" problem should be addressed as follows:

Inquiries involving a particular case in any district court should be addressed to the prosecutor assigned to the case in that court.

Any questions of a general nature or complaints regarding district court matters and any questions regarding motor vehicle homicide matters should be directed to the District Court Supervisor, Assistant District Attorney (note: Inquiries or complaints regarding Fitchburg or Gardner District Court matters should be directed first to Assistant District Attorney at the Fitchburg office).

Inquiries regarding a particular case pending in a Six-member Jury Session should be addressed to the prosecutor assigned to the case in that session.

Any questions of a general nature or complaints regarding jury session matters should be addressed to the supervisor of the session.

Inquiries regarding a particular Superior Court case should be directed to the prosecutor assigned to that case.

Any other inquiries regarding Superior Court matters should be directed to Elizabeth Noonan or Justine Walsh at our main office.

Any legal questions or assistance sought on matters of a general nature should be directed to Elizabeth Noonan or Justin Walsh (the matter will subsequently be directed to an Assistant District Attorney).

Any questions on drug related matters should be directed to First Assistant District Attorney Mary Sawicki

Inquiries on juvenile matters should be directed to Assistant District Attorney Michael Donnelly.

Any questions on fugitive matters or mental health matters should be directed to Assistant District Attorney Supervisor.

Any inquiries about the disposition of cases in CDC or the Jury Sessions can be directed to any secretary or Administrator assigned to those offices.

Inquiries regarding Grand Jury matters should be directed to Assistant District Attorney.
