Eligibility:

- International Association of Firefighters License Plate Any Louisiana certified member of the International Association of Firefighters is eligible for this plate.
- **Professional Firefighter License Plate** Any active full-time professional firefighter is eligible for this type plate.
- Retired Firefighter License Plate Any retired firefighter is eligible for this type plate.
- Volunteer Firefighter License Plate This plate may be issued to any active firefighter of a volunteer fire department.

Requirements:

- One of the following is required for any firefighter specialty license plate:
 - A photocopy of the registration certificate of the vehicle on which the plate will be placed
 if the vehicle is currently registered
 - All necessary documentation required for titling of the vehicle must be submitted along with the request for the plate, if the vehicle is not registered in the applicant's name
- Additional requirements are outlined in the table below.

| Type of Plate | Required Documentation | Documentation Due At | Notes |
|--|--|---------------------------------|---|
| Volunteer Firefighter | A statement from the applicant's fire chief attesting to his status as an active firefighter of a volunteer fire department. | Initial Issuance and Renewal | The plate must be surrendered upon termination of service as a volunteer firefighter. |
| Professional Firefighter | A statement from the fire chief attesting to the applicant's status as an active full-time professional firefighter. | Initial Issuance and Renewal | The plate must be surrendered upon termination of service as a professional firefighter. |
| Retired Firefighter | A statement from the retirement system attesting to the applicant's eligibility. | Initial issuance only | |
| International Association of Firefighter | A statement of good standing from the President of the Professional Firefighters Association of Louisiana | Initial issuance and Renewal | The plate must be surrendered upon termination of service from the Professional Firefighters of Louisiana |

Fees:

- \$25.00 One-time fee or \$25.00 annual royalty fee, in addition to regular registration fees.
- \$8.00 Handling fee (due on all transactions except renewals)
- \$3.50 Administrative handling fee (due only on initial issuance)
- \$3.00 Transfer the plate to another vehicle in the applicant's name

Notes:

- Plates are available for immediate issuance through the Specialized Vehicle Unit.
- Plates may be transferred from one vehicle in applicant's name to another vehicle in applicant's name, but cannot be transferred between owners.
- Based on availability, plates may be issued through any motor vehicle office or public tag agent location.
- Renewal transactions can be processed by any motor vehicle office or public tag agent location.
