**Definitions:**

- **Out-of-State Branded Title-** A title from another state, which bears a notation, such as *Reconditioned, Reconstructed, Rebuilt, Salvage*, etc.

**General:**

- Out-of-state title brands must be carried forward onto the Louisiana *Certificate of Title*.
  - If Louisiana does not have the same brand as notated on the out-of-state title, a comparable or equivalent brand will be added.
    - **Example:** *Rebuilt* brand will be notated as *Reconstructed*.

**Requirements:**

- A file containing an out-of-state branded title must be submitted with the following:
  - [Supporting documents](#) containing the proper chain of ownership
  - Completed *Vehicle Application Form* ([DPSMV1799](#))
  - [Odometer Disclosure Statement](#), if required
  - Applicable fees and taxes
  - A *Disclosure Statement*
    - The *Disclosure* statement located on the reverse of the *Vehicle Application Form* ([DPSMV1799](#)) may be utilized for disclosure of the brand. The applicant must complete and sign *Section G* in its entirety.
    - A completed *Application for Salvage-Reconstructed Motor Vehicle* ([DPSMV1637](#)) is acceptable in lieu of a disclosure statement, if the vehicle is to be branded *Salvaged* or *Reconstructed*.
  - **Affidavit of Physical Inspection** - Must be performed by a full-time Peace Officer Standards and Training (P.O.S.T.) certified law enforcement officer who has been certified by the Department of Public Safety and Corrections, Office of State Police, to inspect motor vehicles, if requested.
